FINAL DECISION

I am the Final Decision-Maker in this administrative appeal ("appeal") by special designation.

On September 26, 2023 the petitioner filed a voluntary withdrawal of this appeal. The petitioner's voluntary withdrawal constitutes a waiver by the petitioner to any further administrative review before the Massachusetts Department of Environmental Protection ("MassDEP" or "the Department") as well as appeal to court of the request for a Superseding Order of Resource Area Delineation ("SORAD") that was issued by the Department of Environmental Protection's Northeast Regional Office on January 13, 2022. Accordingly, the Department issues this final decision incorporating the petitioner's voluntary withdrawal, and dismisses this appeal with prejudice.
