## **FINAL DECISION**

I am the Final Decision-Maker in this administrative appeal (“appeal”) by special designation.

On January 29, 2024 the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”) issued a \$500 Reporting Penalty Assessment Notice (“RPAN”) to R&J Petroleum for failure to submit the UST facility Compliance Certification by the compliance deadline in violation of 310 CMR 80.34(1). On April 22, 2024 the Petitioner unconditionally paid the \$500 RPAN to the Department. The Petitioner’s payment of the \$500 RPAN constitutes a waiver of its claims in this appeal and has rendered the appeal moot. Accordingly, I issue this Final Decision dismissing this appeal as moot.
