## **RMV Service Updates**

- Dedicated Wednesday appointment hours at 17 Service Centers for customers 75 years of age or older extended through February and March; expanded to include all in-person transaction types.
- Appointment System Providing Significant Improvements and Flexibility to Localize and Address Weather-Related Impacts.
- Anticipate Road Test Appointments Returning in Lowell & Worcester in March.
- Planning Sunset of "Renew Online Now / Free REAL ID Upgrade Later" Promotion
  - Will make final push to renew online prior to sun-setting later this spring.
  - Over 385,000 have qualified since promotion launched, though with ongoing pandemic not all are expected to take advantage, nor will need a REAL ID if they have a U.S. Passport or other documentation.
  - Anticipate offering "free" upgrades as soon as this summer for those who qualified.
  - Rebuilding Service Center capacity and working with AAA to accommodate demand.
  - Continuing to monitor federal discussion of October 1, 2021 REAL ID effective date.





#### **RMV Public Safety Updates**

- Continue to Enhance and Promote First-Time Driver Portal, Including New Safety Resources and Educational Tools, Videos, Tips and Guidance for Parents / Guardians, Junior Operators.
  - Practice Learners Permit Exams and Transaction to Order Hard-Copy Driver's Manual Added in January.
    - Almost 13,000 visits to Portal in January most from a mobile device.
    - Over 1,600 practice learners permit exams taken to date.
    - Over 140 orders for 155+ driving manuals to date (free to download online).
  - Need for heightened visibility and understanding evident in new GHSA report showing that from 2015 to 2019, teen drivers and passengers (16-19 years of age) accounted for a greater proportion of speeding-related fatalities (43%) than all other age groups (30%). During this period, 4,930 teen drivers and passengers died in speeding-related crashes.
- Finalizing facial recognition MOU with MSP per new statutory changes.
- Functions within the Merit Rating Board (MRB) and Out-of-State (OOS) Unit remain on track with business goals of processing regular daily incoming citations, notifications and work items.

## Expired "Check Ya Stickah" Campaign

- 584,000+ vehicles in need of required annual emissions & safety inspection (MA Vehicle Check Program) -- essential to the public safety of the Commonwealth's environment and roadways.
  - Some extensions granted at pandemic's outset for stickers expiring March-May of 2020; those have long since expired and no further extensions have been given or are planned.
  - MA has 1,800 Licensed Inspection Stations many of whom are small businesses open and conducting vehicle inspections safely in accordance with all applicable COVID-19 public health guidelines and safety protocols.
- Partnering with law enforcement to encourage use of discretion to remind not cite expired drivers, though violations could result in a fine and impact on individual insurance rates.
- Public awareness campaign launched to encourage customers to update inspection stickers.
  - Email reminder to approx. 437,000 of above individuals with address on record.
  - Website Updates & Social Media Outreach
  - Buck slips to be included in RMV Registration Renewal Reminders
  - Partnering with Law Enforcement, AAA, MassDEP
