The Working Group membership:

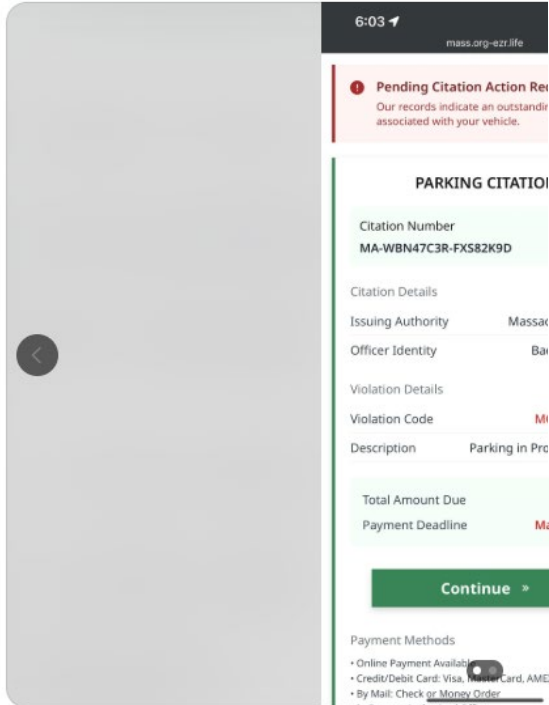
- RMV leadership

SCAM ALERT (No joke... even on April Fools' Day!)

These fake "traffic violation" text messages are about as authentic as an April Fools' Day prank — don't get fooled!

Scammers are sending text messages claiming you owe fines and urging immediate payment. They may even include official-looking documents or QR codes to trick you.

Here's the truth:

The RMV will NEVER text you looking for payment for fines or transactions.

The RMV only accepts payments in person or through the official website: www.mass.gov/RMV

The Massachusetts Trial Court will NEVER text or email you demanding payment

Protect yourself:

Do NOT click links or scan QR codes from unexpected messages

Do NOT provide personal or financial information

When in doubt, go directly to official websites or contact the agency

If it feels suspicious, it probably is. Stay smart and don't let scammers make you the punchline.

- Issuance of a Court Order to Show Cause and potential contempt proceedings
- Possible adverse impact to your credit profile associated with your Social Security Number (SSN)
- Additional enforcement actions as permitted under the Massachusetts General Laws
