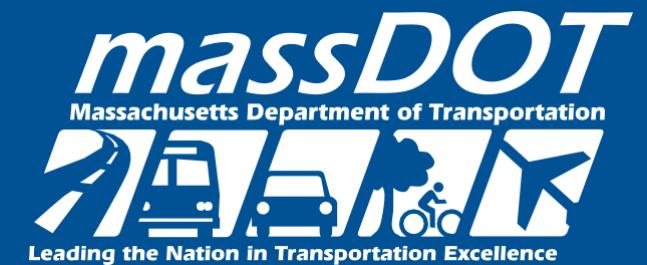




New Skills Test Site – Pittsfield

- 901 East Street, Pittsfield
- Will offer commercial skills testing and passenger skills testing
- Anticipated launch in November 2025



Interim Final Rule for Non-Domiciled Commercial Drivers

FMCSA has issued an interim final rule that makes immediate changes to the eligibility and issuance requirements for Non-Domiciled commercial driver licenses (CDL) and commercial learner permits (CLP). The new requirements are effective as of **September 29, 2025**.

- FMCSA has directed all states pause their Non-Domiciled CDL Program until they can meet the new Rule requirements.
- RMV has paused all transactions related to Non-Domiciled CLPs and CDLs, while we update our policies and business system to be compliant with the new requirements.
- Only those applicants with lawful status in the US in one of the following employment-based nonimmigrant categories will be eligible for a Non-Domiciled CLP or CDL:
 - H-2A (Temporary Agricultural Workers);
 - H-2B (Temporary Non-Agricultural Workers); or
 - E-2 (Treaty Investors)
- Expiration date for non-domiciled CLP or CDL should match the expiration date of the Form I-94/I-94A or 1 year, whichever is sooner and all transactions must be conducted in person
- As of 9/10, Massachusetts had 1,611 active Non-Domiciled CLP and CDL holders. This represents 1.4% of commercial drivers in the Commonwealth.
- The Non-Domiciled program is voluntary. A state does not have to adopt it. The RMV has participated in the program since 2019.

Non-Domiciled Commercial Program Changes

Impact

- Non-Domiciled Commercial Learner Permit (CLP) holders are **not allowed to take a commercial skills road** test during the pause
- Non-Domiciled Commercial Driver's License (CDL) holders may retain their current active CDL unless the RMV's review identifies an issue
 - For those who have an issue identified, RMV is required to cease their commercial credential and downgrade to a class D license
- Non-Domiciled CDLs are expiring each month over next few years with majority expiring in 2026
 - New documentation requirements will reduce the number of people eligible

Communications

- RMV held 3 webinars for industry partners to explain the impact of this new interim federal rule
- Emails and letters have been sent to all Non-Domiciled CDL and CLP holders
- RMV has called Non-Domiciled CLP holders to inform them about the skills test cancellation
- RMV will inform any current drivers who are no longer eligible to retain their Non-Domiciled CDL
- RMV created a Frequently Asked question document to share with industry business partners and other colleagues in government


Out of State Temporary Tags


RMV sent a letter to Department of Motor Vehicles in Rhode Island, Connecticut, New York, Vermont, New Hampshire and Maine to clarify:

- MA issues temporary registration plates valid for 15 days to out of state residents when they purchase a vehicle from a Mass dealer to enable them to drive the vehicle back to their home state to register the vehicle there.
- On a reciprocal basis, MA will honor temporary out-of-state registrations, including ones issued to Mass residents if certain criteria is met.
- RMV provided a Massachusetts Buyer Reminder Sheet to distribute to dealer networks. This will help ensure that MA residents purchasing vehicles out-of-state are aware of the requirements like proof of vehicle insurance meeting MA standards they must follow when driving the vehicle back on a temporary registration.
- Customer needs to apply for Certificate of Title within 10 days and pay sales/use tax in MA by the 20th of the following month


