The Board of Registration in Pharmacy (Board) has not received the Voluntary Surrender Agreement forwarded to you by letter dated April 27, 2007 regarding your Massachusetts Pharmacist Registration (No. 15215), which registration (wallet certificate) you surrendered to the Board (letter of Robert M. Fuster, Esq. dated November 1, 2006) in resolution of above-referenced Complaint Docket No. PH-07-041 concerning certain pending matters in Northern Berkshire District Court (Docket No. 0728CR000378).

Please be advised that the terms and conditions by which the Board has accepted the surrender of your Massachusetts Pharmacy Registration in resolution of the complaint currently pending before the Board as Docket No. PH-07-041 are as follows:

- 1. Your surrender of your pharmacist registration together with any right to renew your registration, to the Board, effective November 1, 2006, was voluntary;
