**ROWLEY LIQUORS INC. D/B/A ROWLEY LIQUORS
144 NEWBURYPORT TURNPIKE
ROWLEY, MA 01969

Rowley Liquors Inc. d/b/a Rowley Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 27, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Bolcome & Anderson's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Bolcome & Anderson's Minimum Purchase Age Compliance Check Field Report, 3/27/2024;
2. ABCC Form 43, Transfer of License Approval, 2/18/2009;
3. Licensee's Stipulation of Facts.

FINDINGS OF FACT


1. On Wednesday, March 27, 2024, at approximately 6:18 p.m., Investigators Bolcome and Anderson ("Investigators"), conducted a compliance check at Rowley Liquors Inc. d/b/a Rowley Liquors.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 18-ounce Bud Light beer for three dollars and seventy-three cents (\$3.73). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2009.

CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.


