Robotics Processing Automation ("Bots") Stage I Registration Form

Providers, trading partners, and relationship entities must complete the registration process to receive authorization to submit transactions using Robotics Processing Automation (RPA) technology tools (bots) on the MassHealth Medicaid Management Information System (MMIS) Provider Online Service Center (POSC). The RPA Stage I Registration Form is the first stage of the two-stage approval process to use bot technology tools to execute transactions on the POSC.

Please note: MassHealth strongly recommends that each bot perform a single POSC transaction (e.g., submit a claim or submit a referral) per session. MassHealth will approve only up to five POSC bot transactions per PID/SL. Organizations may request approval for multiple PID/SLs. Please complete the entire row for each entry. If you are requesting more than 10 bot transactions, please complete an additional form.
- **Column A:** Enter the PID/SL for each bot transaction. If you are requesting approval for multiple PID/SLs that will each submit up to five POSC transactions, please include each PID/SL in Column A.
- **Column B:** Select the POSC transaction that will be performed under each PID/SL from the dropdown list. If the transaction for which you are seeking approval is not listed, please select "Other" from the dropdown list. This includes requests for a bot to perform more than one sequential transaction per session (e.g., check eligibility, and then enter a claim to complete the full transaction).
- Column C: Include any "Other" identified transactions the bot may perform on the POSC.
- Column D: Identify the time of day the bot will be used—e.g., Business Hours 9 am-5 pm; Off hours (overnight).

Column E: Identify the average number of transactions that the bot will perform each week—e.g., 100 Claims Submitted per week.

Column F: Identify the RPA tool or product that each PID/SL will use on the POSC for each requested transaction.
