Welcome and Introductions

Discussion and Vote on Draft Letter of Support for Small business Technical Assistance

Commissioners discussed the draft letter drafted by Dave Christopolis calling for the Governor to restore \$2 million in funding for Small business Technical Assistance in FY19. After a discussion, it was

DEP Educational Program

RPAC Chair Chrystal Kornegay and Commissioner Linda Dunlavy reported that they are still working to identify a potential former DEP staff member to help educate Commissioners on issues surrounding water and sewer.

Discussion on Opportunity Zones

Commissioners briefly discussed Federal Opportunity Zones and raised questions that they have heard from their communities. These concerns centered on how towns apply and how do rural communities that are designated as Opportunity Zones effectively market themselves to investors.

MBI Update

Ed Donnelly from the Massachusetts Broadband Institute was on hand to provide an update to the RPAC. Commissioners commented that they have in the past had trouble receiving regular updates from MBI and asked that they be forwarded any public report that is prepared by MBI staff.

Housing Choice Initiative Briefing

Commissioners welcomed Chris Kluchman, Housing Choice Program Director, to discuss proposals for thresholds to the Housing Choice Grant Program for small or low-growth communities. Commissioners expressed concerns about rural community's ability to compete for grants under the current program and also discussed concerns surrounding capacity to manage these grants in small communities. RPAC Chair Kornegay assured the group that their concerns and recommendations will be taken into consideration and Chris Kluchman offered to come to any community to speak about the program.

Discussion and Vote Draft Executive Director Job Description and Legislative Memo

Commissioners discussed the draft job description for a proposed Executive Director position and a legislative memo. The proposal calls for the creation of an Office of Rural Policy led by a full time Executive Director who reports to the RPAC. Commissioners discussed the proposal, specifically where the organization would be located. Commissioners voted on approving the draft job description and
