1. Discussion/Vote of Meeting Minutes for:

Daniel Kilburn made a motion to approve the meeting minutes for September 26, 2023, November 17, 2023, and November 29, 2023, and December 7, 2023. Paul Maloney seconded the motion. The motion passed unanimously.

2. **Discussion/Votes** for Berkshire East:

These items were discussed in conjunction with a variance request submitted by Berkshire East.

The applications for annual license, and the additionally submitted variance request were considered by the board. It was noted by staff that the new construction application was approved in June 2023 and would not need additional consideration. Paul Maloney made a motion to accept the variance request from 526 CMR 10.00 submitted by Berkshire East as written, and the submitted annual license application for new lift. Daniel Kilburn seconded the motion. The motion passed unanimously.
