駕駛學習者執照是在麻薩諸塞州獲得駕照的第一步

為什麼需要駕駛學習者執照?

• 駕駛學習者執照允許您在練習駕駛技能並準備路考時在麻薩諸塞州合法駕駛。

您需要以下材料才能申請駕駛學習者執照:

- ☑ 填寫完整的駕照、駕駛學習者執照或身份證申請表
- ☑ 至少年滿 16 歲
- ☑ 麻薩諸塞州居住證明(申請 REAL 駕駛學習者執照需要 2 個/而申請駕照或需要 1 個 用於標準學習執照/駕照)
- ☑ 合法在美國相關證明(所有 REAL ID 學習執證/執照或標準商業執照)或身份證明和
 出生日期(標準乘客(D 牌)或摩托車(M 牌)學習執照/駕照)
- ☑ 社會安全號碼或身份證明

<u>請注意</u>:

- 所有檔必須是原件;不接受影本。文檔不得過塑。任何非英文檔必須附有經認證的翻譯檔。
- 駕駛學習者執照有效期為 2 年。如果您的學習執照過期,您需要重新申請並重新參加理論考試。
