DECISION

**MAIN STREET DISCOUNT LIQUORS INC.
83 MAIN STREET
RUTLAND, MA 01543
LICENSE # 00005-PK-1056
HEARD: 6/04/2024**

Main Street Discount Liquors Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, June 4, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators McDonough & Temple's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Special Investigators McDonough & Temple's Minimum Purchase Age Compliance Check Field Report, 3/6/2024;
2. ABCC Form 43, Transfer of License Approval, 1/17/1989;
3. Licensee's Stipulation of Facts.

FINDINGS OF FACT


1. On Wednesday, March 6, 2024, at approximately 5:38 p.m., Special Investigators McDonough & Temple ("Investigators") conducted a compliance check at Main Street Discount Liquors Inc.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one can of Bud Light beer for three dollars and seventy cents (\$3.70). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1989 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
