DECISION

PLEASANTDALE VILLAGE INC. D/B/A COLONIAL WINE & SPIRITS 222 BARRE PAXTON ROAD RUTLAND, MA 01543 LICENSE # 00003-PK-1056

HEARD: 6/04/2024

Pleasantdale Village Inc. d/b/a Colonial Wine & Spirits ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, June 4, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators McDonough & Temple's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Special Investigators McDonough & Temple's Minimum Purchase Age Compliance Check Field Report, 3/6/2024;
- 2. ABCC Form 43, Transfer of License Approval, 5/31/2001;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, March 6, 2024, at approximately 4:57 p.m., Special Investigators McDonough & Temple ("Investigators") conducted a compliance check at Pleasantdale Village, Inc., d/b/a Colonial Wine and Spirits.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25-ounce can of Bud Light beer for three dollars and thirty cents (\$3.30). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2001 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
