		* The latest slide deck did not mention the improvements to the trailhead, including relocating the current signage and dumpster away from each other. I remind you that the Neponset River Greenway Council is willing to take on stewardship of a locking community bulletin board of some kind there to publicize upcoming events in the park and on the trail.			
		* With the expansion of the wading pool and full update of the park, Ryan will attract even more visitors from near and far. That is wonderful! I urge you to NOT give up recreation space to create a truly tiny parking lot; if there are a handful of spaces available, folks will continuously unreasonably hope to get one. If there are none, more people are likely to mode shift altogether and everyone who drives will need to make a plan. I liked the idea of a circular drop off loop, if you're traffic people think it would flow appropriately. I thought Rep Fluker Oakley's suggestion to locate curbside ADA spaces at the other entrance on Meadowbank Ave excellent; google street view shows both houses that abut have large driveways. If you do not do the drop off circle, there could also be 2 ADA spaces parallel to the curb on River Street if you create a "bump in" (opposite of bump out) at the current parking lot entrance.
