MA Occupational Health Surveillance Program (OHSP)

Occupational Health Surveillance Program (OHSP)

- We promote the health, safety, and well-being of all working people in Massachusetts by using occupational health data for action.
- As a program within a state public health department, we conduct surveillance, as well as investigations and referrals to outside enforcement agencies.
- We approach work as a social determinant of health and aim to integrate occupational health within the broader public health model.

Work-Related Respiratory Disease Project

- Work-related asthma and other respiratory disease are reportable to the state health department in Massachusetts. (105 CMR 300.180)
- Possible cases are identified using multiple sources and followed up for an interview.
 - Sources include case reports from health care providers, emergency department visit data, and workers' compensation claims.
- Information is used to identify individual workplaces, hazardous exposures, occupations, and industries that need tailored interventions.

Case Description

- In early 2020, two town maintenance employees had respiratory symptoms attributed to misuse of spraying disinfectants at work.
- This was part of a new and extensive cleaning effort in response to the COVID-19 pandemic.
- Over this time, the affected maintenance workers experienced ongoing and worsening respiratory symptoms, with one reporting specific symptoms of shortness of breath, coughing and wheezing.
- In addition, non-maintenance town employees, including firefighters and police officers, who were also exposed at work to the same disinfectants, reported respiratory and other symptoms, ranging from nosebleeds to seizures.



Factors that Contributed

- 1. Misuse of disinfectants and cleaning equipment
- 2. Insufficient personal protective equipment (PPE)
- 3. Chosen disinfectants and cleaning methods linked to respiratory effects

Cleaning and Disinfecting Products

- Work-related asthma is asthma caused or made worse by exposures in the workplace.
- Cleaning chemicals are a leading exposure among work-related asthma cases.
 - 12% of all work-related asthma cases are from cleaning and disinfecting products in five states including MA.
 - Some cleaning chemicals can cause asthma in someone who has never had asthma.
- The COVID-19 pandemic highlighted this problem as many employees used more cleaning and disinfectant products frequently.

What Can You Do?

- Search for safer cleaning products and support others in your city or town in doing so by sharing resources*
 - Toxics Use Reduction Institute (TURI) Cleaner Solutions
 - Third-party certified: Green Seal and EcoLogo
 - Statewide Contract through MA Operational Services Division

What Can You Do?

- Ensure equipment, application method, and chemical used are compatible and used according to manufacturer's instructions.
 - Disinfectants should be diluted to manufacturer's guidelines.
- Develop and follow a Hazard Communication program.
 - Safety Data Sheets on all chemicals
 - Written safety procedures for job tasks
 - Trainings for employees
 - Chemical warning labels, manufacturer's instructions, chemical hazards, PPE use, and emergency procedures
- Provide appropriate PPE (respirators, gloves, etc.).
 - Consult the SDS and manufacturer's directions for guidance.
