DECISION

KALLONY INC. D/B/A STRIPER'S GRILLE 175 BRIDGE ROAD SALISBURY, MA 01952 LICENSE#: 106600004

VIOLATION DATE: 07/20/2016 HEARING DATE: 09/13/2016

Kallony Inc. d/b/a Striper's Grille (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 13, 2016, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

- 1. Investigator Doyle's Compliance Check Field Report dated July 20, 2016;
- 2. Licensee's Stipulation of Facts;
- 3. ABCC 2016 Compliance Check Guidelines; and
- 4. Photo of Underage Operative.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Wednesday, July 20, 2016, at approximately 6:10 p.m., Investigators Bailey and Doyle ("Investigators") investigated the business operation of Kallony Inc. d/b/a Striper's Grille.
- 2. An underage operative, working with Investigators, was in possession of an alcoholic beverage, a bottle of Budweiser Light beer. The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business more than 10 years and has had no previous violation, the Commission issues a **WARNING**.
