Salisbury Minimart Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 10, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Bolcome and Anderson's Minimum Purchase Age Compliance Check Field Report.

- 1. Investigators Bolcome and Anderson's Minimum Purchase Age Compliance Check Field Report, 5/2/2023;
- 2. ABCC Form 43, New License Approval, 8/18/1998;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Tuesday, May 2, 2023, at approximately 6:05 p.m., Investigators Bolcome and Anderson ("Investigators") conducted a compliance check at Salisbury Minimart Inc.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 23.5-ounce can of Four Loko malted beverage, for three dollars and nine cents (\$3.09). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1998, more than twenty years, with no prior violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
