NOTICE OF SUSPENSION

After a hearing on September 26, 2023, the Commission finds Stateline Liquors, Inc. d/b/a Stateline Liquors violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (4 Counts). The Commission suspends the license for a period of two (2) days to be served.

The suspension shall commence on Monday, May 13, 2024, and terminate on Tuesday, May 14, 2024. The license will be delivered to the Local Licensing Board or its designee on Monday, May 13, 2024, at 9:00 A.M. It will be returned to the licensee on May 15, 2024.

You are advised that pursuant to the provisions of M.G.L. c.138 § 23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form which must be signed by the Licensee and a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

DECISION

STATELINE LIQUORS, INC. D/B/A STATELINE LIQUORS 45 TOLL ROAD SALISBURY, MA 01952 LICENSE#: 89005-PK-1066

VIOLATION DATE: 5/19/2023

HEARD: 9/26/2023

Stateline Liquors, Inc. d/b/a Stateline Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 26, 2023, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (4 Counts). Prior to the commencement of the hearing the Licensee stipulated to facts alleged in Investigator Bolcome's report.

The following documents are in evidence:

- 3. Photograph of Underage #1's Fraudulent Massachusetts Driver's License;
- 4. Photograph of Underage #2's Fraudulent Massachusetts Driver's License;
- 5. Licensee's Stipulation of Facts.
- A. TIPS Certificate of D. Patel.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Friday May 19, 2023, Investigators Anderson and Bolcome ("Investigators") conducted surveillance of Stateline Liquors, Inc. d/b/a Stateline Liquors to determine the way its business was being conducted.
- 2. At approximately 9:15 p.m., while outside the licensed premises, Investigators observed a youthful appearing male individual exit the licensed premises carrying an alcoholic

- beverage. Investigators approached, identified themselves and asked to see proof of legal age to purchase and/or possess alcoholic beverages.
- 3. Underage #1, actual date of birth 11/17/2003 (age 19), was in possession of a 1.75-liter bottle of Tito's vodka. He provided Investigators with a fraudulent Massachusetts driver's license bearing his name but a different birth date.
- 4. Approximately fifteen minutes later as Investigators continued to monitor the premises, they observed a youthful appearing male individual exit the licensed premises carrying alcoholic beverages. Investigators approached, identified themselves and asked to see proof of legal age to purchase and/or possess alcoholic beverages.
- 5. Underage #2, actual date of birth 11/06/2003 (age 19), was in possession of two 10-packs of 50 milliliter nip bottles of Pink Whitney vodka and one 10-pack of 50 milliliter nip bottles of Screwball whisky. He provided Investigators with a fraudulent Massachusetts driver's license bearing his name but a different birth date which he stated he used to purchase the alcoholic beverages.
- 6. At approximately 9:45 p.m., Investigators observed two youthful appearing male individuals exit the licensed premises carrying alcoholic beverages. Investigators approached, identified themselves and asked to see proof of legal age to purchase and/or possess alcoholic beverages.
- 7. Underage #3, actual date of birth 7/05/2003 (age 19), was in possession of one 30-pack of Coors Light beer. He stated that he was not asked for identification when he purchased the beer.
- 8. Underage #4, actual date of birth 5/19/2003 (age 20), was in possession of one 750 milliliter bottle of Jameson whisky. He stated that he was not asked for identification when he purchased the whisky.
- 9. Investigators entered the licensed premises, spoke to the clerk on duty, informed him of the violations, and that a report would be submitted to the Chief Investigator for further action.
- 10. Chirag Patel, Licensee, appeared at the Commission hearing along with the clerk who made the sales to the underage individuals. Mr. Patel testified he now has an identification scanner in place and will ensure all employees, including himself and any newly hired employees, are TIPS certified.
- 11. The Licensee has held a license under M.G.L. c. 138, § 15 since 2017 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (4 Counts). As a result, the Commission suspends the license for a period of five (5) days of which two (2) will be served

and three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.
