DECISION

HUANGS FORTUNE INC. D/B/A GOOD FORTUNE

Huang's Fortune Inc. d/b/a Good Fortune ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 13, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Anderson's Report.

The following documents are in evidence:

1. Investigator Anderson's Minimum Purchase Age Compliance Check Field Report;
2. ABCC Form 43, New License Approval, 2/19/2014;
3. Licensee's Stipulation of Facts.

FINDINGS OF FACT


1. On Thursday, June 2, 2022, at approximately 6:45 p.m., Investigators Bolcome and Anderson ("Investigators"), inspected the business operation of Huang's Fortune Inc. d/b/a Good Fortune.
2. An underage operative, working under the supervision of Investigators, was served an alcoholic beverage, a bottle of Bud Light beer. The underage operative was not asked for identification.
3. Ruby Wang, Licensee, appeared at the Commission hearing along with Donald Lebrun and Shannon Fuller. Mr. Lebrun testified and admitted he served the underage operative but believed the person was over twenty-one years old.

CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.


