



Thank you for being a valued customer of Just Energy. At the end of last year, Just Energy entered into an agreement with the Massachusetts Office of the Attorney General (the "AGO"). Just Energy does not admit to any wrongful conduct in the agreement, however, in recognition of both the concerns of the AGO and the importance of providing accurate information to consumers, Just Energy has agreed to establish a trust fund for the benefit of certain of its current and former customers. The Independent Trustee who administers the trust fund has determined that you are eligible to receive reimbursement for a portion of what you have paid to Just Energy for electricity supply services and/or early termination fees. Accordingly, enclosed is a check in the amount that the Trustee has determined is appropriate:

If the enclosed check has not been cashed within sixty (60) days of the date of this letter, the Trustee will permanently stop payment, and you will be deemed to have waived your right to reimbursement.

If you are or were on a variable or index-variable rate product, attached for reference are the rates Just Energy has historically charged for those products. Similar information regarding the historical rates charged by the utility company serving your community is available on their websites or customer

If you are a current Just Energy customer, for a period of ninety days from the date of this letter, you may choose to terminate your account with Just Energy with no termination fee, and resume electricity supply services from your utility or obtain electricity from another competitive supplier. If you are a Just Energy residential variable rate customer who is not currently on an introductory rate, you will never be subject to a termination fee for the life of your contract.
