Thank you for being a valued customer of Starion Energy. On August 18, 2020, Starion Energy entered into a final judgment by consent with the Massachusetts Office of the Attorney General (the "AGO"). The final judgment resolves the AGO's claims that Starion Energy, Inc. ("Starion") did not comply with certain provisions of the Massachusetts Consumer Protection Act in the course of marketing and selling Starion's electricity supply. Although Starion denied the claims by the AGO, Starion has nevertheless agreed to establish a fund for the benefit of certain of its current and former customers.

The Independent Administrator who administers the Fund has determined that you are eligible to receive reimbursement for a portion of what you have paid to Starion Energy for electricity supply services and/or fees. Accordingly, enclosed is a check in the amount that the Administrator has determined is appropriate.

If the enclosed check has not been cashed by June 6, 2021, the Administrator may permanently stop payment, and you will be deemed to have waived any right to receive money from the Fund.
