#### **DECISION**

M. Z. SONS INC. D/B/A SANDWICH FOOD MART 298 ROUTE 130 SANDWICH, MA 02563 LICENSE#: 1074-00064

M. Z. Sons Inc. d/b/a Sandwich Food Mart (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 24, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34-Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Binienda's Report.

The following documents are in evidence:

- 1. Investigator Binienda's Compliance Check Field Report;
- 2. Licensee Stipulation of Fact;
- 3. Copy of Application Approved 9/24/2008.

#### **FACTS**

- 1. On Monday, July 15, 2019, at approximately 5:48 p.m., Investigators Velez and Binienda ("Investigators") investigated the business of M. Z. Sons Inc. d/b/a Sandwich Food Mart.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 6-pack of Budweiser beer for seven dollars and twenty-nine cents (\$7.29). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2008 with no prior violations.

### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
