DECISION

BOSCY'S LIQUORS, INC. 216 BROADWAY SAUGUS, MA 01906 LICENSE#: 107800047 HEARD: 09/11/2012

Boscy's Liquors, Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 11, 2012, regarding an alleged violation of M.G.L. c. 138 §34- Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (1 Count) according to Investigator Temple's Report.

The following documents are in evidence:

- 1. Investigator Temple's Investigative Report dated May 18, 2012; and
- 2. RMV Printout for Mr. Nou.

There is one (1) audio recording of this hearing.

FACTS

- 1. On Friday, May 18, 2012, at approximately 7:26 p.m., Investigators Capurso and Temple conducted an investigation of Boscy's Liquors, Inc. to determine the manner in which their business was being conducted.
- 2. Investigators conducted a stationary surveillance outside the licensed premises and observed a tan Nissan vehicle pull into the parking lot with three (3) youthful looking male occupants.
- 3. Investigators observed a male passenger, later identified as Mr. Nou, exit the vehicle, enter the licensed premises, and later exit the store in possession of a brown bag.
- 4. Investigators approached the vehicle, identified themselves, and asked to see proof of age from all the occupants.
- 5. The occupants stated they did not have identification but provided information to the investigators: Mr. Nou, date of birth June 25, 1991, age twenty (20) years; Mr. Karpenko, date of birth June 3, 1993, age eighteen (18) years; and Mr. McMaster, date of birth September 14, 1992, age nineteen (19) years.
- 6. Mr. Nou stated that he was not asked for identification when he purchased a 1 liter bottle of Smirnoff Vanilla vodka.
- 7. Investigators went into the licensed premises with Mr. Nou and spoke to the clerk on duty, Mr. Christopher Hamill.
- 8. Mr. Hamill stated that he did not ask Mr. Nou for identification when he made the sale.
- 9. Investigator Capurso informed Mr. Hamill that Mr. Nou was only twenty (20) years old.

- 10. Investigators then spoke with the owner, Mr. Harry Langeaster.
- 11. Investigators identified the underage to Mr. Langeaster, informed him of the violation, and that a report would be submitted to the Chief Investigator for review.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated of M.G.L. c. 138 §34- Sale or delivery of an alcoholic beverage to a person under twenty-one years of age (1 Count). Therefore, the Commission suspends the license for thirteen (13) days of which five (5) days will be served and eight (8) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
