DECISION

MIDWEST GRILL NORTH INC. 910 BROADWAY SAUGUS, MA 01906 LICENSE#: 1078-00016

VIOLATION DATE: 06/15/2017 HEARING DATE: 08/22/2017

Midwest Grill North Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 22, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

- 1. Investigator Di Cicco's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.
- A. TIPS Certificate for G. Pinto; and
- B. TIPS Certificate for D. Jacob.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Thursday, June 15, 2017, at approximately 6:17 p.m., Investigators Guarino-Wilichoski and Di Cicco ("Investigators") investigated the business operation of Midwest Grill North Inc.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Bud Light beer, for five dollars and eighty-nine cents (\$5.89). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for 10 years with no prior violations, the Commission issues a **WARNING**.
