NOTICE OF SUSPENSION

After a hearing on August 7, 2018, the Commission finds Front Street Liquor Inc. d/b/a Scituate Package Store violated M.G.L. c. 138, § 34 Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 count).

The Commission suspends the license for a period of four (4) days of which two (2) days will be served and two (2) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.

The suspension shall commence on Wednesday, October 3, 2018 and terminate on Thursday, October 4, 2018. The license will be delivered to the Local Licensing Board or its designee on Wednesday, October 3, 2018 at 9:00 A.M. It will be returned to the Licensee on October 5, 2018.

You are advised that pursuant to the provisions of M.G.L. c.138 § 23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form which must be signed by the Licensee and a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

DECISION

Front Street Liquor Inc. d/b/a Scituate Package Store (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 7, 2018, regarding an alleged violation of M.G.L. c. 138, § 34 Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 count). Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Kenny's Report.

The following documents are in evidence:

1. Investigator Kenny's Investigative Report;
2. Licensee's Stipulation of Facts;
3. Photocopy of Fraudulent Massachusetts driver's licenses.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FINDINGS OF FACT

1. On Thursday, May 17, 2018, at approximately 9:00 p.m., Investigators Kujawski and Kenny ("Investigators") conducted an investigation of the business operation of Front Street Liquor Inc. d/b/a Scituate Package Store to determine the manner in which its business was being conducted.
2. While outside of the licensed premises Investigators observed a youthful looking male individual enter the store. Shortly thereafter, Investigators observed the individual exit the premises in possession of alcoholic beverages.
3. Investigators identified themselves and asked to see proof of legal age.

4. Underage #1, actual date of birth 12/31/1998 (age 19) was in possession of a 30-pack of Bush beer. He presented to Investigators a fraudulent Connecticut driver's license which he had used to purchase the alcoholic beverages.
5. Investigators informed the clerk on duty, Vanessa Houaye, of the violation and that a report would be filed with the Chief Investigator for further action.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated M.G.L. c. 138, § 34 Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 count). Therefore, the Commission **suspends the license for a period of four (4) days of which two (2) days will be served and two (2) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
