B. Removal of Mercury-Added Switches and Components Before Processing

1) Did you receive any **uncrushed** vehicles at your business during the reporting year?

* If you answered **YES**, **ALL** mercury-added components including mercury-added vehicle switches **and** mercury high intensity discharge (HID) headlamps¹ must be removed before crushing or processing the vehicles during the reporting year per 310 CMR 74.04(1). Components that do **not** need to be removed per 310 CMR 74.04(2) are;

- (a) those that are inaccessible due to significant damage in the area that contained the switch and;
- (b) mercury-added lamps used to backlight the dashboard or electronics.

** If you answered **NO**, the vehicle recycler must provide a written certification on a form approved by the Department for all shipments of crushed, partially crushed, flattened or baled vehicle bodies during the reporting year, specifying that all mercury-added vehicle components were removed per 310 CMR 74.04(3).

¹ Resale of removed mercury switches and other mercury-containing devices are prohibited under 310 CMR 74.05.

C. Management of Mercury-Added Switches and Components

All containers used to store mercury-added switches and components that were removed from vehicles **must be labeled and dated** (the date in which you started to store mercury-added components [310 CMR 30.1034(7)(c)], **in one of the following ways** [310 CMR 30.1034(4)(d)]:

- Universal Waste: Mercury-Containing Switches and Components
- Waste Mercury-Containing Switches and Components
- Used Mercury- Containing Switches and Components

Once mercury-added switches and components start being collected in a container, they must be shipped off-site to a facility licensed to handle mercury [310 CMR 30.1037(1)], within one year of the date in which you started storing the items [310 CMR 30.1034(7)(b)].

All containers must be sent to a licensed hazardous waste or recycling firm identified below or to EQ Industrial Services under the End of Life Vehicle Solutions (ELVS) program.
