MHS Refunding Recap

- Bonds were originally issued by the Turnpike Authority in 1997 and advance refunded in 2010. We had a one-time historic opportunity to current-refund the original bonds at near historically low interest rates for significant savings.
- Refunded approximately \$830 million in MHS Bonds
- Bonds were priced on October 2nd and closed on October 23rd
- **Net Savings of \$182.3 million**
 - Higher than original estimate (June) of \$161 million
- Savings from this transaction (approximately \$14 million annually) can further support additional capital needs for the MHS and Allston project.
- This refunding **does not impact/change/amend** toll rates (determined by the Board) or toll locations (restricted by statute).

IRAP Grants: Applications and Awards

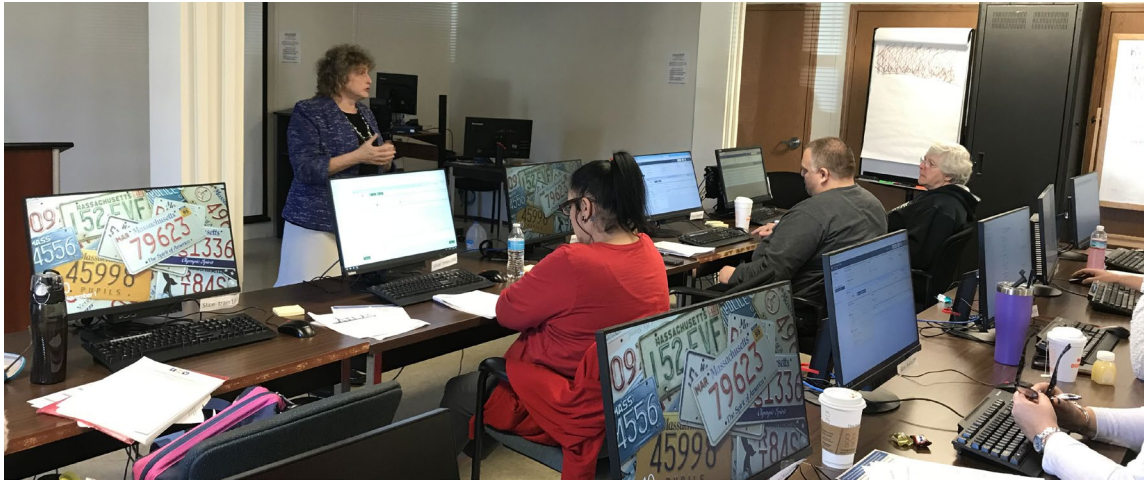
Industrial Rail Access Program (IRAP)
is a public/private partnership program

Funds to help applicants invest in freight rail
infrastructure improvement projects that:

- help get trucks off the road
- stimulate economic development
- grow Massachusetts corporations
- support/create manufacturing jobs through
 - increased efficiency, production capacity
 - improved distribution logistics

FY20 Grant Round

- 20 applications received
- 9 awards made:
 - 3 to railroads
 - 6 to shippers/receivers
- \$2,756,722 total in awards
- Matched by \$3,302,913 in private funds



After months of training , planning, and implementing lessons learned, the RMV team launched the second phase of its technology upgrade (vehicle information)



Atlas 2 on November 12
- 1.4 billion vehicle-related documents successfully conveyed

Registry will report back to the board on this transition in future months, when more data on performance becomes available

Transportation Climate Initiative (TCI)

- Massachusetts (MassDOT, EEA, Governor's Office) joined 11 other states and the District of Columbia to discuss and further develop this emissions reduction program.
 - We anticipate a significant announcement in December
- Reminder: “Cap and invest” – and other mechanisms being considered to establish a price for transportation emissions.
- Under TCI “cap and invest” price of gas would go up or down in response to macroeconomic conditions.
 - Funding created under TCI would be invested to providing low and no carbon transportation options through the Commonwealth

Kelley Square Improvements

Worcester, MA

In partnership with City of Worcester, this \$14 million project re-imagines and rebuilds Kelley Square – an infamously complex and dangerous intersection

Project will address safety and operational deficiencies for all users - motorists, bicyclists and pedestrians, while also supporting the local businesses and residents who call Kelley Square their home
