### South Coast Rail Program

- Phase 1 Finance Plan now complete & fully funded in the Commonwealth's Capital Investment Plan.
- After 3 independent reviews, consensus achieved for Phase 1 program cost: \$1.047 billion.
- U.S. Army Corps of Engineers has approved the final federal permit required. All major federal and state permits now approved.
- Early action steps are underway including infrastructure work, acquisition of land for stations, surveying, etc.

### Boston Harbor Now: business plans

- On Tuesday, April 23, Boston Harbor Now will host a panel discussion and release business plans for potential new ferry routes in Boston Harbor.
- Boston Harbor Now, MassDOT, MBTA, and Massport are among many stakeholders who worked on the plans.
- Next steps include gauging interest from the private sector, municipalities and other stakeholders to fund potential routes and pay for operating and capital costs.

### Commute Options Grants: New Initiative

- New initiative goal: to encourage innovative workforce transportation options.
- Why? Current travel options do not work for people not using cars, employees with off-hour shifts, for getting places requiring several transit transfers.
- Initiative: use \$1.5 million a year of federal Congestion Mitigation and Air Quality (CMAQ) money to create new grant program. Annual application process.
- New grant funds can be used for capital assets such as vans, for portion of operating costs, etc.
- MassDOT will host "listening sessions" state-wide to explain this new initiative & get feedback.

# Registry Wait Times

Customer experience for in-person transactions has dramatically improved in the last year:

- School vacation week for most districts was last week and the Registry of Motor Vehicles last week served more than 51,000 customers at its service locations.
- Last week, on average, 76 % of customers got in and out of a service center in 30 minutes or less, 19 % waited between 30 and 60 minutes, and just 4 % waited 60 minutes or longer.
- That is a dramatic improvement from one year ago. During April school vacation week in 2018, fewer than 43,000 customers were served but only 36 % got in and out in 30 minutes or less, 18 % waited between 30 to 60 minutes and 46 % of customers a year ago had to wait 60 minutes or more.
