After observing the correct technique by the Trainer, completes a proficient return demonstration. 9. Knows how to care for and store the individual's specific equipment. 10. Knows the manufacturer's requirements (e.g., storage, test procedure, etc.) for the individual's blood glucose meter when 11. obtaining a blood glucose level and knows where the original manufacturer's instructions are kept. Knows the safe disposal procedures of used equipment (e.g., lancets, test strips, etc.). **Individual-Specific Training Documentation:** The 'Individual-Specific' Training must be completed by a Qualified Trainer.
