On 1-24-16 at approx: 0239hrs. I was dispatched to the area of Lincoln St. and Perkins St. to assist in a reported accident with injury. Streets Dept. radio 413 called over the police band and stated that a vehicle had hit something and the operator is slumped over the wheel.

Upon my arrival [found Mass Reg#2YX936, a 2002 Black Chevy Avalanche with heavy front end damage, stopped, in the South bound lane of Lincoln St. (a public way in the city of Worcester). I pulled my marked cruiser, with emergency lights activated, behind the vehicle to alert other motorists. I exited my cruiser and approached the drivers side door. Officer Bishop had stopped in front of the Vehicle and approached the passenger side. Once there, I observed a male, later identified as Mr. Jorge Zambrano dob: 3-14-81, slumped over, leaning towards the passenger side. I was able to open the drivers side door and asked him if he was ok. At this time I noticed a large Pitt Bull, sitting on the passenger side floor. The male was making mumbling sounds and I could not understand what he was saying. I asked him if he needed an

Mr. Zambrano then grabbed the front of my uniform shirt and pulled me further into the vehicle. He then stated " Fuck you , you piece of Shit ". At this time the Pitt Bull had jumped into the passenger seat and I was, now, face to face with it. I pushed off of Mr. Zambrano and while doing so, I told him to get his hands off of me. I grabbed onto him and pulled him out of the truck. Mr. Zambrano was quickly put up against the truck with the assistance of Officer Bishop. Mr. Zambrano continued to struggle and refuse to put his hands behind his back. The road surface was slippery due to the earlier snowfall. Officer Welch had no arrived and with his assistance, Mr. Zambrano was placed in double locked hand cuffs. Once in cuffs, Mr. Zambrano continued to struggle and attempted, several times to break away from our grasp. For his safety and ours, he was then seated on the groundWhile waiting-for-the-wagon, Mr. Zambrano stated, numerous times, " I'm going to kick your. Ass ", "your lucky these cuffs are on me ". He also stated " wait till 1 get out " '' mgoing to find you ". Mr. Zambrano was calling out our last names " LaHair, Welch, I'll remember you ". The wagon soon arrived and transported him back to the station. He is charged with A+B on a PO and Resisting arrest. Sgt. Bossolt had arrived and was explained the incident. Animal control was called for the Pitt Bull and responded, however, the owner of the dog, a Miss. Heather Philip dob: 1-16-82 arrived and took the animal. The vehicle was cited with Worc-Parking-ticket WP1002693057 for more than 12 inches from the curb and was authorized for tow by Sgt. Bossolt. Blvd Garage then responded and towed the vehicle.

Upon arrival the undersigned observed a black Chevy Avalanche MaTag 2YX936 with heavy front end damage in the middle of the road obstructing public travel. The undersigned also observed a pitbull (identified as Gage) in the passenger seat as well as a male later identified as Jorge Zambrano dob 03/14/81 slumped to the right side in the driver seat. PO LaHair went to the driver side to check on Zambrano while the undersigned went to the passenger side. The undersigned heard PO LaHair ask a couple times if Zambrano was ok. The undersigned then heard PO LaHair say something about keeping his hands off of him. At this time the undersigned went to the driver side to assist PO LaHair. PO LaHair was attempting to pull Zambrano out of the vehicle do to Gage. The undersigned assisted grabbing on to his left arm. Once out of the vehicle the undersigned closed the door so Gage would not get out. PO Welch also came to assist. While attempting to cuff Zambrano he kept moving refusing to place his hands behind his back stating your not going to cuff me. After a brief struggle Zambrano was cuffed. While in cuffs he began to struggle again. For Zambrano's safety as well as ours Zambrano was taken to the ground and legs held down until the wagon arrived. The undersigned spoke to Heather Philip dob 1/16/82 who states that Zambrano was her boyfriend. Philip asked about her dog Gage. Philip was advised that animal control was called in to pick him up. As animal control arrived Philip was brought to Lincoln St to pick up Gage. Philip was very thankful and apologetic. Okayed by Sgt Bossolt Philip and Gage were transported to Union Station with PO LaHair following.
