(1) On 27 April 2014 about 0005hrs, Officer Patrick Harrington and I were on patrol in a marked cruiser in the area of Sterling Street. Just prior to the start of our patrol there had been a shooting on Suffield Street a short distance away involving two victims. Due to the recent incidents of violence in the area including another shooting and a suspicious item which turned out to be a pipe bomb, we were in the area as part of a saturation patrol to increase police presence due to the hazard brought to the public's safety.

(2) At this time we observed two males walking separately on Sterling Street, one on the sidewalk and the other on the street near several parked cars. The male walking on the sidewalk appeared to be hiding himself behind the cars as he saw our cruiser and the male in the street just continued walking. At the same time there was a car flashing its headlights in our direction a short distance away and thinking that the operator of the mv was attempting to draw our attention to the two males. Upon see the suspicious activity we notified Officer Allan Burnes who was in the area and he came to assist us.

(3) As Officer Burnes arrived we exited our cruisers and immediately the male who was walking on the sidewalk who was now at the intersection of Windham Street and Sterling Street, began to yell "What the fuck." He was recognized by Officer Burnes as Jorge Zambrano who is well known to the police. At the same time the other male who was later identified as Michael Giangregorio who is also known to the police, stopped and began to reach towards his pockets as we approached him. I immediately told Giangregorio not to do that for our safety. I then grabbed Giangregorio by his left wrist and escorted him to the front of Officer Burnes' cruiser and began to frisk him for our safety. As I felt the outer clothing of his front right pocket I could feel a hard squared object inside of it. As I examined the contents of his pockets I observed a clear zip lock bag that contained several small round pills. I looked at the pills and recognized them to be Oxycodone and Giangregorio spontaneously uttered "There Perc 20"s." I know from experience that people involved in the illegal narcotics trade sell the pills individually and recognized them to be for sale and not for personal use. I then placed Giangregorio in handcuffs behind his back (dl) and advised him that he was under arrest. I confirmed the pills to be Oxycodone through a pill identifier app on my iPhone.

(4) As this was happening Zambrano continued yelling "This is bull shit why are you fucking with us" and he was uncooperative with Officer Burnes. During the disturbance that Zambrano was creating one mv on Sterling Street slowed down to look on at the incident and another stopped as it approached us on Windham Street for several moments before turning around and leaving the area. At this time Officer Burnes informed Zambrano to put his hands behind his back and that he was under arrest. Officer Burnes placed Zambrano in handcuffs (dl) behind his back and during his search discovered a black handled folding knife in his front right pocket. At this time we notified dispatch and requested the wagon. A short time later the wagon arrived to transport both Giangregorio and Zambrano to the station for booking.
