Honorable Chairs and Ranking Minority Members of the Committees on Ways and Means:

Pursuant to Section 6 of Chapter 14 of the General Laws<sup>1</sup>, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of September 2016. The attached table shows September 2016 month-to-date and Fiscal Year 2017 year-to-date tax revenue collections through September 15, 2016, along with changes from the same collection period in September 2015.

### **Context for September estimates**

September is one of the larger collection months, contributing roughly 10% of yearly collections on average. This reflects the fact that Estimated Payments are due for both individual and business taxpayers in September. Please note, however, that the preponderance of the Estimated Payments are received in the second half of the month, and therefore are not reflected in this mid-month view.

At the time of the mid-month estimate, the available tax collection data is too early to provide a reliable estimate of full-month results. It would not be advisable to use this data to predict trends.

## **Highlights**

- Total Tax Collections for the month-to-date period were \$1.291 billion, up \$131 million from the same period last year. For the year-to-date period of Fiscal Year 2017 (July 1 through September 15), Total Tax Collections were \$4.734 billion, which \$175 million more than the same period in FY16.
- **Income Taxes** totaled \$681million, up \$61 million from the mid-month September 2016. On a fiscal year-to-date basis, Income Taxes were \$2.610 billion, up \$104 million.
- Sales & Use Tax collections were \$88 million at mid-month, up \$5 million from the same period last September. For the fiscal year-to-date, Sales & Use revenues were \$1.153 billion, up \$12 million.
- Corporate & Business Taxes totaled \$451 million, up \$65 million from the same period last September. For the fiscal year-to-date, collections were \$541 million, up \$58 million.
- Other Taxes totaled \$72 million for September mid-month and \$431 million fiscal year-to-date, which represent almost no change from the same period last year.

#### Detail

The **Income Tax total** of \$681 million for mid-month September comprises the following:

- **Income Withholding** of \$534 million, which is \$72 million above mid-month September 2015.
- **Estimated Payments** of \$146 million in the month-to-date period, down \$9 million versus same period last year.
- **Income Returns/Bills** of \$16 million, \$1 million more than the equivalent period in 2015.
- **Income Refunds** of \$15 million is \$3 million more than the same period last September.

**Sales & Use Tax collections** of \$88 million comprise \$40 million in Regular Sales, \$15 million in Meals, and \$34 million in Motor Vehicles.

- As the exhibit shows, Regular Sales and Meals are above mid-month September 2015, but Motor Vehicles is down slightly.
- Note that Regular Sales and Meals collections are heavily weighted to the second half of the month, so the figures above represent a relatively small portion of collections.

We do not use the mid-month figures to project full-month results because collections are heavily weighted to the end of the month, making the mid-month results unreliable as predictors.
