1. Continuing Education Credits for Renewal

DISCUSSION:

Ms. DeSilva asked if the Board could discuss changes to contact hours required for license renewals. Ms. Strachan reminded the Board that the changes to the required CEUs had gone through the public hearing process and the Board made the change from 15 required CEUs to 20 required CEUs for the 2020-22 renewal cycle. Ms. Karen Geoghegan clarified that Board Staff had not posted the new regulations yet as the Executive Order from Governor Baker extended the 2018-20 renewal cycle, for which the new regulations have not taken effect. Ms. Strachan noted that, at the Board's request, she could write a notice to be posted to the Board's website clarifying the new regulations.

2. CEU Standardization.

DISCUSSION:

Mr. Moury asked if the Board could discuss setting a Board standard for accepting CEUs for Advanced Cardiac Life Support (ACLS), Neonatal Resuscitation Program (NRP), and Pediatric Advanced Life Support (PALS) at future board meeting. Ms. Strachan reminded the Board members that the Board currently has a regulation for Advanced Cardiac Life Support that states that the Board accepts CEU credits for ACLS, but does not accept CEUs for Basic Life Support Training. She added that regulations are currently silent on CEUs for NRP and PALS. Mr. Moury noted that he had done some research on the topic and would forward the information he found about how many credits other RC Boards award for these courses.
