Incorporating feedback to develop final recommendations & report to Healey-Driscoll Administration. Announcement will kick-off state-wide Biodiversity Campaign.

THREATS TO BIODIVERSITY





POLLUTION OF LANDS & WATERS

Ecosystems are significantly degraded legacy + present day pollution threatens ecosystems and human health.

HABITAT LOSS

We are losing critical natural spaces —conversion of habitat and changes in hydrology threaten essential remaining habitats.

ENVIRONMENTAL JUSTICE

Stark disparities exist in access to nature and its many benefits, guiding investments and action to address this is key.

INVASIVE SPECIES

Fast growing, non native terrestrial and aquatic plants, invasive species outcompete native species and **overtake the ecosystem**.

HABITAT FRAGMENTATION

Poorly placed infrastructure—defunct dams, undersized culverts, excessive pavement—**fragments habitats,** blocking wildlife migration + harming our state's ability to withstand climate impacts.

CLIMATE CRISIS

Climate change is amplifying threats— Without action, we will see loss of essential species + habitats that sustain us, threatening our public health, safety, food security, and economy.

NATURE IN NEIGHBORHOODS

- Ensure every person has access to a **biodiverse greenspace** (pocket forest, urban garden, food forest, pollinator pathway) in walking distance of their home
- Supporting municipal and community led initiatives
- Biodiversity Toolkit for municipalities (e.g. native planting, land use, Dark Skies initiatives)



FOOD SECURITY

SUSTAINABLE HARVEST

- Support **farms in applying biodiversity-friendly practices** for healthy soils, pollinator edges, agroforestry, intercropping
- Ensure No Net Loss of Farmland
- Bolster food security by growing "Hunters Share the Harvest" + "Share the Catch"
- Management plans for marine fish & invertebrates that reflect climate change



NATURE IN THE CLASSROOM

Investments in Lynn

Executive Office of Energy and Environmental Affairs (EEA)

September 2024

Lynn Harbor Park





EEA is assisting the City of Lynn with the design of a large-scale public park on Lynn Harbor.

Priority of the Lynn Waterfront Open Space Master Plan, funded by EEA.

EEA awarded \$8M grant to support construction. City of Lynn funding \$3.6M.


King's Beach



Priority to address historic pollution and improve water quality so that the public can fully enjoy the beach

Supporting local efforts led by Lynn and Swampscott, and the King's Beach Steering Commitee

EEA, DEP and EPA providing expertise to inform evaluation of possible solutions





Northern Strand Trail





Environmental Justice Population Areas along the Northern Strand



EEA provided \$15.5m in funding through the Gateway City Parks Program for the design, permitting, and construction of 10.5 miles of the Northern Strand between Western Avenue in Lynn and the Mystic River, which opened in the fall of 2022.

MassTrails provided funding for the public engagement, design & permitting of the section which will connect the trail to the waterfront in Nahant and provide safer and improved transportation access for bicycles and pedestrians.



Lynn Heritage State Park







DCR is investing in Lynn Heritage State Park. Key features of the project include new paths, connection to the Harbor Walk, new plantings, a splash pad, benches, an improved parking lot and drainage, and a renovated boardwalk and fishing pier.



DCR Willis Fishing Pier

DCR invested \$1.169 million in renovations to the Willis Fish Pier, completed in late fall 2021.

Project included replacement of pile caps, timber substructure decking and handrails, the installation of new timber handrails, new benches and bait cutting stations.

- **Parkland Acquisitions and Communities (PARC) FY24:** \$350,000 for Lynn Commons to bring the park's fountain back online and to renovate the plaza.
- Municipal Vulnerability Preparedness (MVP) FY24: \$190,000 for design and permitting of a climate resilient recreational park, the continuation of a watershed-scale flood resilience study, to reduce flooding at the G.E.A.A. field.
- Greening the Gateway Cities (GGCP) FY25: \$123,981 to prepare 80 new tree pits and assistance to plant 110 new public trees. In addition, the City will provide tree stewardship and assist with community engagement to promote GGCP.
