The Massachusetts Department of Correction (DOC) frequently offers voluntary, mobile COVID-19 testing to staff. Testing locations vary to allow staff working in all regions, a convenient test location.¹ This report is based on a culmination of data collected from the mobile testing sites and information self-reported by staff² as of September 30, 2021.

For staff testing at mobile testing sites, there were zero new confirmed positive COVID-19 test results self-reported by staff as of September 30, 2021.

Occupations of Staff Members Self-Reporting a Positive COVID-19 Test
