Subject: Services to Migrant and Seasonal Farmworkers Training

Purpose: To inform Local Workforce Investment Boards, One-Stop Career Center

Operators, and other local workforce investment partners of the upcoming Services to Migrant and Seasonal Farmworker (MSFW) Training schedule.

Background: The Wagner-Peyser Act and the implementing regulations (20 CFR 651 – 658) require

that the services provided to Migrant Seasonal Farmworkers (MSFWs) by the One-Stop Career Centers (OSCCS) be "qualitatively equivalent and quantitatively proportionate" to the services provided to other jobseekers. The regulations also mandate that the State Monitor Advocate (SMA) ensure continued compliance with the program requirements, and to assist improve the State Workforce Agency (SWA) capacity to deliver services to farmworkers through the One-Stop Career Centers (OSCCs) on an equitable and non-

discriminatory manner.

Further, the State Monitor Advocate is required to meet with OSCCs staff and other WIA partners to discuss the state's capability for providing services to MSFWs during the upcoming harvest season.

Accordingly, Managers, Supervisors or other appropriate OSCC front line staffs involved with direct provision of services are *required* to attend one of the training sessions.
