DECISION

SHERBORN FUEL LLC D/B/A SHERBORN MARKET 21 SOUTH MAIN STREET SHERBORN, MA 01770 LICENSE#: 00008-PK-1112

Sherborn Fuel LLC d/b/a Sherborn Market ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, July 8, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: Ch. 138 § 34 – Sale or Delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Cutter & Teehan's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Cutter & Teehan's Minimum Purchase Age Compliance Check Field Report, 4/2/2025;
- 2. ABCC Form 43, New License Approval, 3/9/2012;
- 3. Licensee Stipulation of Facts.

FINDINGS OF FACT

- 1. On Saturday, April 2, 2025, at approximately 6:01 p.m., Investigators Cutter & Teehan ("Investigators") conducted a compliance check at Sherborn Fuel LLC d/b/a Sherborn Market.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 6-pack Bud Light beer for eight dollars and twenty-five cents (\$8.25). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2012.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
