In order for the ICA to be truly independent and unbiased, we recommend that the Health Policy Commission (HPC) conduct the analysis at the Applicant's expense, or at a minimum, the Department work closely with HPC staff to select an independent third party, establish the scope of the ICA, and review the ICA prior to the Department's acceptance thereof. As part of the review, we respectfully suggest that the ICA consider the implications of this individual Application as well as the other MBG DoN Applications (MGB-20121716-HE and 2102113-AS) collectively.
