These taxpayers are acting on behalf of Shields Health Care Group located at 700 Congress Street, Suite 204 Quincy, MA 02169.

The TTG respectfully requests that a public hearing be held on this Application. Additionally, we strongly encourage the Department of Public Health to require an independent cost analysis (ICA) pursuant to 105 CMR 100.405(D) and M.G.L. c. 111, § 25C(h) to provide additional information as to whether the Proposed Project is consistent with the Commonwealth's cost containment goals. In order for the ICA to be truly independent and unbiased, we recommend that the Health Policy Commission (HPC) conduct the analysis at the Applicant's expense, or at a minimum, the Department work closely with HPC staff to select an independent third party, establish the scope of the ICA, and review the ICA prior to the Department's acceptance thereof. As part of the review, we respectfully suggest that the ICA consider the implications of this individual Application as well as the other MBG DoN Applications (MGB-20121716-HE and 20121612-HE) collectively.
