#### **DECISION**

PICCOLINO'S INC. 4 MILL STREET SHIRLEY, MA 02536

Piccolino's Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 20, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Di Cicco & Keefe's Minimum Purchase Age Compliance Check Field Report.

## FINDINGS OF FACT

- 1. On Monday, May 20, 2024, at approximately 8:11 p.m., Investigators Di Cicco and Keefe ("Investigators"), conducted a compliance check at Piccolino's Inc.
- 2. An underage operative working under the supervision of Investigators purchased an alcoholic beverage, one bottle of Bud Light beer, for four dollars and seventy-five cents (\$4.75). The underage operative was not asked for identification.
- 3. The Licensee has held a license for more than ten years with no previous violations.

### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
