DECISION

RAMANDEEP, INC. DBA BOLLYWOOD GRILL
QUINSIGAMOND PLAZA, UNIT A3
SHREWSBURY, MA 01545

Ramandeep, Inc. dba Bollywood Grill (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 10, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Doyle's Report.

1. Investigator Bailey's Compliance Check Field Report dated June 12, 2013;
 2. Licensee's Stipulation of Facts;
 3. Compliance Check Guidelines;
 4. Minor's Release to Conduct Compliance Check; and

FACTS


1. On Wednesday, June 12, 2013, at approximately 5:50 p.m., Investigators Doyle and Bailey conducted an investigation of the business operation of Ramandeep, Inc. dba Bollywood Grill.
2. An underage operative working with investigators purchased an alcoholic beverage, a bottle of Budweiser Light beer, for four dollars and thirty cents (\$4.30). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. As the licensee has been in business for sixteen (16) years and has had no previous violations, the Commission issues a **WARNING**.
