Dear Mr. Lefebvre,

I am writing to request that you to immediately sever all ties with ICE and cease providing services that support ICE's deportation flights out of Hanscom Field.

You no doubt are aware that ICE's actions over the past year have stoked fear and violence in communities in Massachusetts and across the country. People have been shot and killed. Mothers have been ripped from cars and separated from children. U.S. Citizens have been stopped and detained, and peaceful protestors assaulted. ICE has done all this while violating constitutional rights, due process, and court orders.

You also should know that a significant majority of people detained by ICE in Massachusetts over the past year have *no* criminal convictions or charges. They are hard-working, productive, and beloved members of our community who have been indiscriminately targeted for deportation proceedings.

The use of private flights has allowed ICE to supercharge these deportation efforts. ICE uses private flights to quickly remove residents and sever them from their family, friends, community, and legal counsel, obstructing due process of law. As an American taxpayer, I also find it beyond comprehension that ICE's budget to execute this harmful agenda is more than the budget for all state and local law enforcement – combined.


As the only FBO serving ICE at Hanscom, Signature Aviation is essential to the operation of ICE's private deportation flights at the airport. You are the charter companies' point of contact, you ensure that the planes are fueled up, your personnel open the gates to allow ICE's vehicles into the airport, and you escort ICE's vehicles with detainees to the tarmac and into the

deportation planes. It is not hyperbole to say that if Signature Aviation stopped supporting ICE's flights, ICE would be unable to operate out of Hanscom Field.

Signature Aviation is the largest fixed based operator in the country. On your website, you promote your company as "not just working to elevate our private aviation experiences" but also "always thinking about the bigger picture: our world, our place in it, our legacy, and our communities."

I am asking you to think long and hard about Signature Aviation's "place" in the world and what you want your "legacy" as a company to be. You have a choice to either continue profiting from ICE's unlawful tactics that are depriving people of due process and separating parents from their children, or you can stand with the people and communities you say that you serve. I urge Signature and its owners to stand with our people and communities and cease supporting ICE's damaging deportation efforts immediately. Enough is enough.
