Population Health	Improve management of chronic conditions and reduce rates of preventable health conditions by 2017.	<ul style="list-style-type: none">▪ Access to Pediatric Behavioral Health (BH) Consultation▪ Electronic Referrals to Community Resources

FEDERAL EVALUATION SITE VISIT

The Center for Medicare & Medicaid Innovation (CMMI) has contracted with RTI International (RTI) to conduct an independent evaluation of the SIM program.

SIM Project Update – Recent Achievements

MASSHEALTH PRIMARY CARE PAYMENT REFORM

PCPR released the first raw claims file extract to the participating practices January 1st. The release included supporting job aids for both the medical and pharmacy claims files. Upcoming enhancements include inclusion of behavioral health claims.

ALL-PAYER CLAIMS DATABASE (APCD) PROVIDER PORTAL

The Center for Health Information and Analysis (CHIA) developed product wireframes for the All-Payer Claims Database (APCD) Provider Portal and conducted user feedback sessions with stakeholders to test the value and uses of model reports.

DATA INFRASTRUCTURE FOR LONG-TERM SERVICES AND SUPPORTS

The Executive Office of Elder Affairs (EOEA) launched the pilot implementation of Caregiver Direct (Caregiver & Consumer access to an Electronic Health Record composed of the home care LTSS service plan & history). Two (2) ASAPs are participating in pilot, with 6 caregivers able to access records.

SIM Project Update – Upcoming Activities

COMMUNITY LINKS PORTAL

EOEA plans to increase the number of ASAP partnerships with health care organizations using CLP from 13 to 20, and expects the number of active Home Care consumers visible through the portal to reach 1250 (currently 803).

MASSHEALTH PRIMARY CARE PAYMENT REFORM

MassHealth will conduct practice site visits to monitor compliance with the contractual 12 month milestones. Key milestones include:

- Development of multidisciplinary teams for empaneled members
- Behavioral health integration infrastructure
- Training and resources allocation
- Mass Hlway connectivity and MU Stage 2 status (where applicable)

ACO EFFICIENCY AND PROVIDER PRACTICE VARIATION STUDIES

The Group Insurance Commission plans to release the baseline report for the ACO efficiency study.
