24	And Mr. McInerney, I want to
25	again ask your permission. We have the next

1 witness ready on Zoom, which we expect to have ready on Zoom at 11:00. And if he's ready at 2 3 11:00, we'll want to interrupt this witness. **HEARING OFFICER:** 4 Yes. 5 MS. MULVEY: That's fine. 6 **HEARING OFFICER:** Yes. 7 JUDGE FABRICANT: Thank you. DIRECT EXAMINATION 8 9 BY JUDGE FABRICANT: 10 Good morning. 0. 11 A. Morning. 12 Q. Please state your name. 13 A. Shannon McDermott. 14 Q. And Ms. McDermott, please tell us your 15 professional background. 16 A. I started as an assistant district attorney in 2015 for the Middlesex County DA's office, 17 18 where I worked for four years, then in September 19 of 2019, I worked at Keney & Sams, a small 20 office in Boston, until March of 2020, then I

- and then in May of 2021 I became an assistant
- clerk magistrate at Malden District Court, which
- I still am today.
 - Q. I'm going to ask you a lot of questions about

went to the Suffolk District Attorney's office,

1	April of 2018. And I know that that's nearly
2	actually, it's a little more than seven years
3	ago, so it's challenging to take your mind back
4	to that time, but that's what I need to ask you
5	to do.

As of April 2nd of 2018, what was your position?

- A. I was the only district attorney at the Newton District Court.
- Q. In that capacity, did you have a title of supervisor?
- A. Yes.

- Q. And what was your role? What did you do?

 A. So as I said, I was the only assistant district attorney in Newton District Court, so I was assigned to prosecute all of the cases that came through that courthouse, supervise myself, and the victim witness advocate, and then there was one, you know, staff, support staff that helped as well. That was really our whole office there.
- Q. So were you in the courtroom every day?

 A. Yes.
- Q. And every time a case was called before the court, were you the person standing up?

- 1 A. Yes.
- 2 Q. Where was your office?
- A. My office was in the Newton Police Station,
- 4 which the building is connected to the
- 5 Newton District Court. I was on the second
- floor, which is within the detective bureau.
- 7 Q. Was there another office in the courthouse
- 8 associated with district attorney's office?
- 9 A. Yes.
- 10 O. Who used that office?
- 11 A. The victim witness advocate.
- 12 Q. Did you ever work in that office?
- A. I did not.
- 14 Q. As of April 2nd of 2018, how long had you been
- in that role in the Newton District court?
- 16 A. I believe I went to Newton in March, so about
- a month, few weeks.
- 18 Q. About how many arrests were there in the
- Newton District Court? Say, how many a week?
- A. Not many. Not many at all. Five, maybe,
- 21 would be average. I guess I could bring it up
- to 10, but I think that would have been rare.
- Just roughly. My best guess.
- 24 Q. When in court you worked in, not regular.
- A. Exactly.

- 1 Q. Did you have occasion to deal with ICE
 2 detainers?
- A. Yes.

- Q. And what was the practice about ICE detainers,
 about the paperwork, who would get it, when,
 how?
 - A. There is a couple ways. Sometimes I would get it when I got the packet in the morning from the police department, the police prosecutor, with the new arrests for that day, sometimes it would be in it, sometimes I know it gets sent to the clerk's office, so sometimes I would get it from them. There was a couple of different ways that I could have obtained that paperwork.
 - Q. Would it be something that you would get?A. Yes, yes, at that time.
 - Q. And were you aware in the course of the day who else would get it, who else would have it?
 A. I know that the clerk's office got it and that it was always something given to the security department, the court officer. I don't know who else got it.
 - Q. When you're in the courtroom in Newton, where do you sit or stand?
 - A. Well, the main courtroom, as you walk in,

- there's a left -- there's a table on the left, table on the right, and mine was on the left.
- Q. And let's bring up the Photograph 509, which was received in evidence yesterday.
- 5 Okay. So you see photograph on the monitor.
- And can you just indicate on the photograph
- 7 where would be your place?
- 8 A. I think I was on the left.
- 9 Q. Okay. And what is -- If you're on the left, at

 10 that chair and table, what's immediately to your

 11 left?
- 12 A. With the glass?
- 13 Q. Yes.
- A. That would be the dock, we call it, where a custody comes up from lockup.
- 16 Q. So a person in custody would be in that dock.
- A. Correct. Now that I'm looking at this, I
- could have been in the left or right chair. I
- don't remember.
- Q. Do you see in the glass in the dock something that looks like a metal circle?
- Q. What is that?

A. Yes.

A. I don't know if it was a speaker or if it was amplified it all. I can't remember. But it was

- just a way for the person in the dock to hear better in that area.
 - Q. And if an interpreter was helping a defendant in the dock, where would the interpreter stand?
 A. They would be outside along, you know, that small alleyway on the left talking through that metal piece.
 - Q. So when you say "outside," you mean outside the dock?
 - A. Correct.

- 11 Q. And talking through that metal piece?

 12 A. Correct.
 - Q. Again, taking your mind back to April of 2018.

 When a defendant was in custody and was then released from custody, how would that happen?

 A. If they were going to be released, the court officer, who -- you can't see it, but there would be a little seat to the left outside the photo where there's a court officer seat, and they would just unlock the door to the dock and they would walk right out.

JUDGE FABRICANT: Let's bring up photo Number 513, Page 513.

Q. Does this show what you were just talking about?

A. Yes.

- And was what you can see, the piece of furniture 1 Q. 2 that you can see on the left, is that the court 3 officer's station that you're talking about? 4 A. Yes.
- And the door that you can see there that looks Q. like it's slightly ajar in the photo, is that 6 7 the door that you're talking about? A. Yes.
 - And -- So you said the court officer would go in Q. there and pick up restraints and would the person just come out?
- 12 A. Yes.

- 13 And then when the person's leaving the Q. 14 courtroom, how does the person leave the 15 courtroom?
- 16 A. The door in the back of the courtroom.
- 17 JUDGE FABRICANT: And why don't we bring up -- We'll get to the photograph that 18 19 shows that. There it is. And what number is 20 this?
- 21 All right. So this is numbered Page 512 of the Q. 22 appendix. Does this show the door that you're 23 referring to?
- 24 A. Yes.
 - Q. And Photograph 509 was already received in

1		evidence yesterday. Photograph 513 and 512, do
2		those fairly and accurately depict what you
3		described?
4		A. Yes.
5		JUDGE FABRICANT: And I offer
6		those in evidence.
7		MS. MULVEY: No objection.
8	Q.	What if a defendant had property downstairs?
9		We're talking now about a defendant who doesn't
10		have to go check in with probation, doesn't need
11		the bail posted, is being released. What is the
12		property How would the defendant get the
13		property?
14		A. My best memory is one of the court officers
15		would just run it up to them.
16	Q.	On that date, April 2nd of 2018, I want to draw
17		your attention to a case involving a
18		Mr. Medina Perez. Do you remember the charges?
19		A. Yes.
20	Q.	What were the charges?
21		A. There was a possession of a drug charge, I
22		think it was B, but I don't remember, and a
23		fugitive from justice charge.
24	Q.	And what's a fugitive from justice charge?

A. It's a mechanism to kind of hold somebody

- when they have an out of state warrant, so the language of the charge is fugitive from justice from X state for Y charges.
 - Q. So it's a Massachusetts criminal charge for the purpose of effectuating a warrant from another state.
- 7 A. Correct.

- Q. On that day, with respect to Mr. Medina Perez, you said he had a drug charge and a fugitive from justice charge. Were you also aware of an ICE detainer?
- 12 A. Yes.
- Q. And was there an ICE officer in the courtroom for part of the day?
- A. Yes. At some point they arrived.
- 16 Q. And did you speak with him?
- A. Yes, at some point.
- Q. And did he show you a photograph or a video or something to that effect?
- A. I don't remember a video. He had paperwork that he showed me.
- Q. Okay. Did you notify others of the presence of ICE and the detainer?
- A. I'm sure I mentioned the detainer. I don't know whether I told others about the ICE officer

- or not. There wasn't very many people there.
 - Q. Did you become aware at some point in the course of the day that the ICE officer left the courtroom?
- 5 A. Yes.

- Q. And do you know what caused the ICE officer to leave the courtroom?
- A. My understanding is he was asked to wait outside.
- 10 Q. Do you know who asked him to wait outside?
- A. I think it was the judge asked someone to ask
- 12 him. I don't remember exactly how it happened,
- I guess is my answer.
- 14 Q. Do you know where he went?
- A. I think he just went right in the hallway.
- 16 Q. In the hallway, the main lobby of the
- 17 courthouse?
- 18 A. Correct.
- 19 Q. Was the case called, the Medina Perez case
- 20 called a number of times over --
- 21 A. Yes.
- 22 (INTERRUPTION)
- 23 HEARING OFFICER: Okay. It's
- 24 not playing anymore; so...
- JUDGE FABRICANT: Okay.

- 1 Q. So the case was called a number of times over 2 the course of the day?
- And was it then put on for further call? 4 Q. 5 A. Several times, yes.

A. Yes.

- 6 Q. And during the course of the morning, what 7 information did you have about the Pennsylvania warrant?
 - A. I knew that it was not -- I guess Pennsylvania OUI/DUI charge. I'm sure I had a piece of paper reflecting that. I don't remember what other supporting documents I had for that.
 - Q. Did you at some point in the morning inform the court that you were going to ask to detain the defendant on the fugitive from justice charge? A. Yes, at first I did.
 - Q. And why was that your position at that point? A. So generally the practice that we were taught in the DA's office when there's a fugitive from justice charge, you reach out to the out of state body, sheriff's office, the police and see if it's something that they want to come extradite, come pick the person up for. times they say yes. Sometimes they say no.

- When they say yes, we ask that we hold without
 bail pending the out of state authorities coming
 to pick up the person to face the warrant in the
 other court -- in the other state.
 - Q. And in the course of the morning, when you were taking that position, had you yet been in touch with the Pennsylvania authorities?
 - A. I don't recall. I don't remember.
 - Q. At some point later on in the course of the day did you get more information? Did you get a photograph?
- 12 A. Yes.

- Q. And did you review the photograph with the defendant's attorney?
 - A. I reviewed it with a couple of people. But it was the booking photo from Pennsylvania is what someone gave me and I can't remember who.

 That is what I reviewed with definitely a couple
- 19 people.
- Q. And in the course of the morning, did you take a position regarding bail on the Massachusetts charges?
- A. Yes. I was not going to be asking for bail on the possession charge.
 - Q. And why was that?

- A. At the time in my office, the mandate was on nonviolent misdemeanors. We were not to ask for bail.
 - Q. And I want to just call your attention to a transcript of the proceeding. This is Appendix G. I want to take a look at Page 39 at the bottom of the page and going into Page 40. And you have in front of you a book that has all of the appendices that have been received in evidence. So if it's easier to look at that, rather than refer to the monitor, that's fine.

So looking at Page 39, at the bottom and going over to the top of Page 40, so do you see where, five lines from the bottom, the judge asks Commonwealth with respect to new charges, is there going to be a request? What did you understand, is there going to be a request?

- A. A bail request.
- Q. Okay. And what did you say?
- A. I said no, Your Honor.
 - Q. And the judge says okay. And what did you say?A. I said, well, not on the drug possession.
 - Q. And the judge says that the possession that -- and then what did you say?

- A. If they're treated separately, I'm not going to ask that he's held without.
- Q. And what did you mean by "if they're treated separately"?
- A. The state charges are the Newton -- I don't remember if it was state police or Newton. The charge versus the fugitive from justice charge.
 - Q. And then the judge says, right on the fugitive.
 What did you say?
- 10 A. But if he's not, I would have bail request.
- 11 O. So if he's not what?
- A. So sometimes you argue -- Sometimes a judge
 won't hold somebody without bail on a fugitive
 charge, in which case I would have asked for a
 number on the same.
- 16 Q. Bail on the fugitive charge.
- 17 A. Correct.
- 18 Q. But not bail on the misdemeanors.
- 19 A. No.

- Q. All right. Now, in the afternoon, did

 Attorney Jellinek appear for the defendant?

 A. Yes.
- Q. And at the beginning of when he appeared, did
 you and he go to side bar?
- A. At some point we went to side bar. I don't

- 1 recall at what point that was.
- Q. So we're going to bring up a transcript again,
 starting at Page 40, and we're going to go to
 2:48:13 p.m. And we're going to play the
 recording. The initial part of the recording is
 pretty good, but you can see the transcript. So
 we're going to play the recording at

2:48:13 p.m. until the end of that first clip.

- Q. So does that refresh your memory that

 Mr. Jellinek asked to go to side bar and you

 went to side bar?
- 13 A. Yes.

- Q. Did you have an understanding of why you were going to side bar?
- A. No, not before.
- JUDGE FABRICANT: Let's put up

 Photograph Number 511 if we could.
- Q. Is this where -- This is Number 511 of
 Appendix U. This was admitted in evidence
 yesterday. Does this show where you would be at
 side bar?
- 23 A. Yes.
- Q. And where would the judge be when you're at side bar?

- A. The judge would just stay in the chair and kind of shuffle over to the, closer to the right side of the photograph, and the attorneys would stand on the outside, on the right side.
 - Q. And is there a microphone for the recording system at that part of the bench?A. Yes. I can't see it in the photo, but there's the little black microphone.
 - Q. Now, we're going to go back to play the recording. Now that we're at side bar, it's much harder to hear. But again, we have the transcript starting with at the bottom of Page 40 and going over to page 41.

(RECORDING PLAYING)

- Q. So looking at the transcript, at the beginning,

 Judge Joseph says something inaudible is

 dismissed. What was it that was being

 dismissed?
 - A. The fugitive from justice charge.
- Q. And then she says, so it's my understanding that
 ICE is here.
- 22 A. Yes.

Q. Attorney Jellinek says, so there's fugitive.

Judge Joseph says, if there's no warrant. What

did you understand that to be referring to?

- A. If I was going to dismiss the fugitive from justice charge, then there's no out of state

 Pennsylvania warrant.
- Q. And you then said yes; is that right?

 A. Yes.
- Q. And then Attorney Jellinek says, there isn't something inaudible that we can tie this to him.

 What do you understand that to refer to?

 A. I believe the Pennsylvania warrant.
- 10 Q. And then you said, I don't think it's him. Is that right?
- 12 A. Yes.
- Q. And was that also in reference to the Pennsylvania warrant?
- A. Correct.
- 16 And Judge Joseph said, okay. And then Ο. Judge (verbatim) Jellinek says, ICE is convinced 17 18 that this guy, and he goes on and talks about 19 his discussion with the ICE agent and what he 20 saw in the records. And he says, ICE is going 21 to pick him up if he walks out the front door, 22 but I think the best thing for us to do is to 23 clear the fugitive issue, release him on a 24 personal, and hope he can avoid ICE. You said, 25 I don't think ICE is really my -- Is that right?

- 1 Is that what you said?
- A. Yes.
- 3 Q. What did you mean by that?
- A. I think I finished it somehow in the transcript saying, ICE has nothing to do with my role as a prosecutor.
- Q. And so what was your view about any discussion relating to this?
 - A. That I did not have an opinion or a standing, it's not my job, doesn't have anything to do with my job.
- 12 Q. Were you neutral about it?
- 13 A. Yes.

- Q. So a little later the judge says, the other
 alternative is if you need more time to figure
 this out until tomorrow. Attorney Jellinek says

- A. Just I think before he said that, it was something to the effect of, you know, what could we do and him saying, I have a plan, it's all set. Logistic.
- Q. And again, did you have concern about that?

 A. Yeah. The conversation made me

 uncomfortable.
- 16 Q. And why did it make you uncomfortable?

remember when.

- A. Because my training was that ICE, that just didn't play a calculus in a criminal case.
- Q. In the course of the discussion at side bar,
 whether on or off the record, was there
 discussion about where the ICE officer was
 waiting?
- A. At some point in the day there was. I don't

And then you said, with the information I have, I don't think there's enough tying to the Pennsylvania warrant but that there are other out of state records, I do believe that some of them belong to this individual, but that's not what's at issue, and then shortly

thereafter you said you were going to dismiss the fugitive from justice charge.

Was there something a little off sequence in his saying it and then you saying it?

A. I mean, yes. I am the only person that can move to dismiss it.

HEARING OFFICER: I'm sorry.

 - Q. If the defendant is not in the courtroom, is being brought up, you're waiting for him, but he's not yet in the courtroom, he's not yet in the dock, and there is something going on, where would you be?
 - A. Well, in Newton, it was, it was different.

 It was set up differently. Like there was a chair specifically set up for the interpreters.

 So that was usually -- you're facing the court, usually on the left side. There could have been one on the right side as well, but usually on the left side in that particular courtroom.

 Normally, in most courtrooms you're sitting behind the defendant -- the defense or the

- prosecuting attorney, they have a section for you to sit at.
- Q. And is that always where you were or did you at times move around?
- A. Yeah. I was able to move around. And as the hearings went through the day, I might sit closer towards either the attorneys, just to be able to listen and approach the court quicker.
 - Q. I want to call your attention to April 2nd of 2018.

 A. I'm not sure of the dates. It would have been about, about a year and, about a year and four months prior to this, prior to this case.
 - Q. And you were working at the time for a woman named Ms. Barrios; is that correct?

 A. Correct.

 A. I believe so. I think so, yeah.
- Q. Okay. And it would be fair to say that you never saw him again until he was brought up in the afternoon; right?
- 19 A. Correct.
- Q. So in the morning there was a discussion that
 you interpreted about whether they had the right
 individual that Pennsylvania wanted; correct?

 A. Yeah. They needed --
- 24 Q. I'm sorry?
- A. Yes. They needed to confirm because

- everybody was worried of the fact that ICE was
 there. So they wanted to make sure who he was
 and what was going to be done.
 - Q. Well, so you say they were worried about ICE being there. Did you hear any discussion about ICE in the morning?
 - A. Yes. Well, we were kind of -- I'm kind of like a court employee. So we're somewhat notified just for safety sake that ICE may be present.
 - Q. Okay. So ICE was there. But what did you hear that there was some concern that ICE was there?

 And from whom?
 - A. I guess our concern was from the employees or people that were there that ICE was present.
 - Q. Okay. But you never heard anything said by the judge in the morning about ICE; correct?

 A. I, I don't think so, no.
 - Q. And do you remember, was there an announcement that ICE was not allowed in the courtroom in the morning or not?
 - A. I don't remember that announcement.
- Q. Okay. And so did you see anybody that was -that you knew to be an ICE officer in the
 courtroom in the morning?

 14 pronounced the Lunn or the Lunn policy. Have

- A. And whether I know it or not, they're going
 to operate either way whether the judge lets it
 or not or whether ICE, ICE is going to do

 - A. In the afternoon session, I'm still there, whether there's -- until I'm dismissed by the judge.

 - Q. But you weren't over by the dock because there was nobody in the dock when the case was first called; correct?

- Q. And so do you remember whether or not, when the case was called, the parties stayed talking to the judge in the open court or do you remember if they went to side bar?
 - A. I'm not sure what you're asking.
- Q. Do you have any memory of where the conversation between the two lawyers and the judge first took place in the afternoon about Medina Perez?
 - A. It started open and then it went to side bar.
- Q. And so when it was open, you would have been next to the conversation or next to the lawyers; correct?
- A. I was kind of behind the attorney, because the defendant wasn't out there yet.

- Q. And you said I thought he's coming out the frontdoor.
- 21 A. Yes.
- Q. And that's the truth, isn't it?

 A. It is.
- Q. Now, if somebody in that courtroom had said, either at side bar or out loud, we've made a

- decision that he's going to go out the back

 door, that's the kind of thing you'd remember,

 isn't it?
- A. Yes.
- 5 Q. Did that happen?
- A. Not to my memory.
- 7 Q. Would you forget something like that?
- 8 A. I don't think I would have.
- 9 Q. Now, you said about Judge Joseph, in response to
- one of Special Counsel Fabricant's questions,
- you thought that she had made a misguided
- 12 attempt to do what she thought was right?
- A. I did say that.
- 14 Q. And you had no reason to believe, having been
- present at side bar, that she knew that
- 16 David Jellinek was going to have released out
- the back door, do you?
- A. I do not.
- 19 Q. And when you say a misguided attempt to do what
- she thought was right, are you referring to the
- 21 idea that maybe there was a way that ICE
- 22 wouldn't get him?
- A. Right.
- Q. Okay. Now, at side bar David Jellinek was
- 25 claiming very vociferously that his client was

- 1 not the guy ICE was looking for; right?
- A. Yes.
- Q. And certainly, no one would want ICE to take the
- 4 wrong guy, would they?
- 5 A. No.
- 6 Q. That's not a good thing, is it?
- 7 A. It is not.
- 8 Q. All right. And so what Judge Joseph was
- 9 actually doing was offering David Jellinek time
- 10 to try to convince ICE this wasn't the guy.
- A. I don't know if that's what the offer was for
- or not.
- Q. Well, you know that that's what she had been
- doing all morning, right, giving more time?
- A. The more time, for me, I thought was to
- 16 figure out the Pennsylvania warrant.
- 17 Q. All right.
- 18 A. But...
- 19 Q. But not just you, but Attorney Bostwick was
- 20 asking for more time; right?
- 21 A. Correct. Yeah. Absolutely.
- 22 Q. And there was a second call and a third call --
- A. Absolutely.
- 24 O. -- and a fourth call?
- A. Many, yes.

- Q. All right. And all of those were with you and Attorney Bostwick; is that right?
 - A. I don't remember at which point
- 4 Attorney Bostwick withdrew because of the
- 5 private appearance by Attorney Jellinek, but
- 6 Attorney Bostwick was certainly there in the
- 7 morning, and at some point, that I can't recall,
- 8 Attorney Jellinek came in.
- 9 Q. Well, let's see if we can try to shed a little
- 10 light on that. Do you have the book of exhibits
- 11 there?

- 12 A. I do.
- 13 Q. And would you take a look at Exhibit H, please.
- 14 And Exhibit H is a transcript of the full day.
- Can you take my word for that?
- A. Yes. I am with you.
- 17 Q. All right. And if you could, would you look at
- 18 Page 147.
- A. I'm sorry. Are we talking about within the
- 20 transcript?
- 21 Q. Yes.
- 22 HEARING OFFICER: Can you give
- 23 us the --
- 24 Q. The transcript page, not physical page.
- A. Okay. I'm here.

- Q. All right. And if we look at Line 16, the clerk is saying, and that's just, Judge, that leaves us with Mr. Perez and Attorney Bostwick, are you still, and Ms. Bostwick says I just sent a fax?

 A. Yes, I see that.
- 6 Q. Do you remember that happening?
- 7 A. Not specifically but...
- Q. All right. But we can tell from the transcript
 Ms. Bostwick was still there representing
 Medina Perez and she was trying to sort out the
 identity issue; --
- 12 A. Yes.
- 13 Q. -- is that right?
- 14 A. Yes.
- Q. All right. And then Judge Joseph asked

 Mr. Harrington whether he needed more time.
- Right? Do you see that, the next line?
- A. I do see the next line that says that as well.
- Q. All right. And if we flip over to two pages
 later, 149, there's a period where Judge Joseph
 and the clerk are talking to Mr. Harrington; is
 that right?
- 24 A. Yes.
- Q. And again, you would be there because you'd be

- representing the Commonwealth on that case,
 whatever it was?
- A. Correct.
- Q. All right. And then if we get to Page 149, and we look at Line 18, do you see that?

 A. Yes.
- Q. All right. Then Ms. Bostwick is speaking again?A. Yes.
- And she says, I will, and then she says, I 9 Q. think, Your Honor, I have an appointment this 10 11 afternoon and I wanted to ask if we could have 12 a -- I understand that the interpreter has to be 13 somewhere as well, if maybe we could have 14 Mr. Medina's case called at 2:15 or so, so that 15 would give me time and then we're not just 16 waiting, and the clerk says, at 2:15. 17 A. Yes.
 - Q. Do you recall that happening?

 A. Not specifically, but it sounds right.
 - Q. All right. And then if we flip to Page 150,
 Ms. Bostwick says, somewhere, and then the clerk
 interrupts and says, and the interpreter's okay
 with that, too, 2:15, and Ms. Bostwick says, I
 have a medical appointment at 1:30, Judge Joseph
 says, not a problem, Ms. Bostwick says, so I

- Q. Okay. And you said, and you pointed it out, I
 don't think arguing ICE is really my, and that
 means you're not getting involved in is he the
 guy ICE is looking for or not.

- Q. All right. And David Jellinek at the end says,

 I think the best thing for us to do is to clear

 the fugitive issue, release him on a personal,

- and hope that he can avoid ICE. Now, did you
 interpret that as meaning I'm going to let him
 out the back door?
 - A. I did not.

- 5 Q. What did you think that meant?
- A. That he was going to try to figure a way for him to avoid the ICE officer, but I didn't know how.

 once again offering this defendant's lawyer time

- 5 O. ICE could come back.
- A. Yes.
- Q. And we can pick up where we left off and see if

 David Jellinek had had any luck convincing ICE

 this wasn't the guy; right?
- 10 A. Yeah.
- Q. All right. And there would be nothing wrong with that, would there?
- A. Well, holding someone without bail on an ICE
- 14 detainer I don't think is part of the bail
- consideration. So that's -- What I thought was,
- maybe we were still talking about the
- Pennsylvania warrant. I don't recall. It could
- 18 have been both.
- 19 Q. Okay. But there's a couple of parts there.

- 14 A. Absolutely.
- Q. And vice-versa. You could say I'm not asking for bail and the judge can say I have concerns
 I'm going to set bail.
- 18 A. Sure.
- 19 Q. That's the judge's role.
- A. Absolutely.
- Q. And one of the things that might make a
 defendant likely not to show up is if he's not
 the guy everybody's talking about.
- A. Sure.
- 25 Q. And so if you had concerns about or if a judge

 wouldn't be unreasonable to impose bail to make

- Q. Okay. Now, you've been dragged into this and asked questions on a number of occasions; is that right?

- Q. All right. Now, the first time you were interviewed by somebody from the U.S. Attorney's office; is that right?

- 9 Q. And if I suggested to you that was in October of 10 2018, does that sound about right?
- 11 A. Yes. That could be right.
- 12 Q. And that was a phone call?
- A. I don't remember, but probably.

Q. Okay. I'm going to ask you to give us a general description of the physical layout of the building and the courtroom. We're going to put up some photographs to assist in this. So let's start with Photograph 509, Page 509, Appendix U.

And Mr. Okstein, in front of you on the witness stand is a binder that has a set of exhibits that have been received in evidence. The photographs are at Tab U. So you can look at them there or you can look at them on the screen, whatever is easier. And there are page numbers in the upper right-hand corner, and those are the page numbers that I'm going to refer to.

So what do you see here in Photograph Number Page 509?

- A. So -- Page 509. Are they marked page numbers?
- Q. In the upper right-hand corner, there's a red number. Actually, in the book --
- A. I see the numbers. Okay.
- So on Page 509 I see what appears to be the first session of the Newton District Court.
 - Q. And what are we looking at from the perspective

of this photograph?

- A. So you're looking at a shot of where the judge sits, which is the far back, with the seat, what appears to be the false bookcase, if you will, in the back with two flags, and then in front of where the judge sits is where the session clerk or whoever's covering for the session clerk would sit, and then the litigants would be at the table that you see where -- with the two chairs, and then if there was a custody, the person in custody would be where you see the glass enclosure up close.
- Q. Is that referred to as the dock?A. The dock, yes.
- Q. And let's pull up Photograph Page 506. And what do you see here?
 - A. So Page 506 is a picture, a photograph of the entranceway to the clerk magistrate's office, so the first floor of the Newton District Court.
 - Q. If you're coming out -- Looking at this photograph, if you're walking out the door of the courtroom, the public door of the courtroom, where are you in this photograph?
 - A. So you can just make out the bench that's on the left-hand side. The door to the first

- session is just past that bench, on the right-hand side.
 - Q. And so you'd be coming out and turning to your left to go into the clerk magistrate's office if you're coming out of the courtroom?
 - A. Yes. Yes. If you walk out of the first session courtroom, you walk out and you turn to your left, that's what you would see. This is the view.
 - Q. If you're in the clerk's office, in your office, and you're going into the courtroom, is there another way to get there?
 - A. There is. So if you walk through the clerk's office, there is a back entranceway into the courtroom.
 - Q. And does that lead to a secure door on the side of the courtroom?
 - A. Yes. So the only people that are allowed back there are court personnel, court officers, clerks, judges. And so, yes, that was the secure area back there.
 - Q. And do you need a security pass to open that door?
 - A. Yes, you need a pass and you put it up to the little reader.

- Q. Did you hear any of their conversation?

- Q. And then at some point did you go back on the record?
- A. I did.
- Q. And let's play the back on the record part.

- Q. What did you intend to be asking her or conveying to her at that point?
- A. So I was conveying the ICE officer's or agent's request to visit the lockup to take the individual he was interested in into custody.
- Q. Was that the request you told us about a little while ago?

A. Yes.

- Q. And her response, that's fine, I'm not going to allow them to come in here, but he's been released on this, how did you understand that response?
 - A. I understood that response to be following the practice of the court, that officer was an agent, wasn't coming into the courtroom, wasn't coming into the courtroom to go down into the lockup, but she was releasing the prisoner and he was free to leave, and whatever happened after that was between him and ICE.
- Q. And did you have any understanding as to whether ICE could go to the lockup another way?
- A. I think at that time there was a policy that

1	indicated that ICE agents were permitted to go
2	to lockup. I had never seen them in Newton go
3	to the lockup. I had never seen that. But I
4	think under the policy that the court put out to
5	all the clerks and judges, I think that a judge
6	could allow it.

- Q. And did you understand that Judge Joseph was allowing it?
 - A. No. As I understood it, Judge Joseph was saying the agent was not permitted to come into the courtroom down the stairs through the courtroom to lockup but that she was releasing him and he was, the individual was free to leave, and then she was just following the practice of the court, that this gentleman would leave and if the ICE agent wanted to take him into custody he would.
- Q. And the practice of the court, are you referring to Judge Heffernan's practice?
 - A. Yes. Well, refer to Judge Heffernan's practice, but more specifically, that's what I believe that Judge Joseph was following.
- Q. And what was the practice of the court as to how a defendant would leave the courtroom when the defendant was released from custody?

- A. So after we were done with, with my reading what happened in the case, and Attorney Jellinek walked down the stairs to the lockup with the court officer and the interpreter and then a defendant, I -- the hearing was over, I went out of the courtroom, the ICE officer was waiting in the hallway, and I conveyed to him that the -- you know, what had happened, that he could not go down to the lockup, that the individual would be -- was released from custody and would be coming up and going out the front door.
- Q. And what was the basis for your telling the ICE officer that he couldn't go to the lockup?
 A. That's how I understood -- That's what I understood Judge Joseph's decision to be in that respect.
- Q. At some point did the ICE officer express a concern to you?
 - A. He did. He didn't say anything specifically. He was more speaking of, there was another individual in the courtroom with the defendant, and he expressed that he was alone that day at the Newton District Court and he was going to call another agent to come assist him so he -- That's what he expressed initially.

- Q. Did he express concern about being alone?

 A. Yes. He expressed concern about being alone
 and that the defendant had a friend, he wasn't
 sure who the friend was, but he was in the
 courtroom waiting for him; so...
 - Q. And did you do something about that?
 A. So yeah. When he expressed his concern about that situation, I called the chief court officer, who was in his office downstairs, and expressed to him that I'd be more comfortable if he came upstairs and stayed with the ICE agent to make sure that there was no confrontation to occur, and he did, he came up.
 - Q. And at some point -- That conversation you just talked about, you have an officer who's concerned, so you called the chief court officer, can you place that in time?

 A. So, again, that would have been after the hearing was conducted, that would have been while the defendant, the defense attorney, the interpreter, the court officer were downstairs. So that's -- When they were all downstairs, I was on the first floor by the front door in the hallway area, and that's where the ICE representative was. So it was sometime after

- the hearing concluded but before the court closed at 4:30.
 - Q. And the chief court officer -A. He came right up, yeah.
 - Q. And did you or the chief court officer tell the ICE officer where you expected the defendant to come out?
 - A. So yeah. Definitely one of us did. I don't remember if it was me. I definitely, if I was asked, I would have said the front door. I just don't remember if it was the chief who said the front door or myself. But I would have said that if I was asked.
 - O. And the front door of what?
 - A. The front door of the courthouse. So opposite the courtroom, when you walk out of the first session, you literally walk right out the courthouse right through the doors.
 - Q. When you're having this conversation, are you outside the building or inside the building?
 A. I'm inside the building in the hallway with the ICE officer and at that point with the chief court officer.
 - Q. And where -- How were you expecting the defendant to come into that hallway, what we've

1	been	referring	to	as	the	main	lobby	of	the
2	court	house?							

- A. I was expecting that the defendant would be -- I guess not -- "supervise" isn't the right word, but accompanied by a court officer, brought up the steps, and then they would walk out the front door.
- Q. So is that the stairway that comes from the probation counter?
 - A. Yes. That's where the public would go down.
- Q. At some point that day did you become aware that the defendant wasn't coming out into the main lobby?
 - A. So I stayed with the chief court officer and the ICE officer for probably about five or 10 minutes, and then I left to do other things that I needed to do to close up the court. But in that five or 10 minutes, the prosecutor had come out of the courtroom. I don't know what she had been doing prior. But she came out of the courtroom and she asked, you know, whatever they were still doing here. I asked the ICE officer what he was still doing here. I was somewhat surprised that he was still there. And he said that he was waiting for the defendant to come

- out through the door that we told him was going to happen. So...
 - Q. And did you at some point learn what had happened?
 - A. Yes. So it became clear as we approached the 4:30 time frame, when the court's closing up, that the defendant wasn't coming out. We also saw the defense attorney came up and walked by the ICE agent and the prosecutor and the chief court officer and walked out the door for the day. So he was leaving. So I wasn't sure where his client was, but he was leaving.
- Q. The next day, was Judge Heffernan back in Newton District Court?
 - A. I believe it was the next day. I don't -I'm not a hundred percent sure. I believe it
 was the very next time I saw Judge Heffernan, I
 think it was the next day.
 - Q. So you're not sure which day the next time -A. No. I think it was April 3rd, the next day,
 but it could have been April 4th. I just don't
 remember exactly.
- Q. Did you have a conversation with her?

 A. I did.
 - Q. Tell us about that conversation, please.

- A. So typically, when Judge Heffernan is not in the court, when she comes back to the court, she'll ask did everything go okay, is there anything I should know about or any problems, because she's just trying to monitor how the day went for everybody. And I let her know that there was an issue, I didn't quite understand at that time the magnitude fully, but I said there was an issue with this person leaving the court not through the front door and the ICE agent was waiting and wasn't able to take him into custody.
- Q. And did you talk to her at all about the recording?
 - A. I did. I let her know that -- She asked me a little bit about the hearing and what had happened, and I was trying to remember what had happened and in my mind tell her. And I did, I did say at some point the tape was off, and that's it.
 - Q. Did you at some point listen to the recording?
 A. I did. I listened to the recording. Because I was trying to figure out, I was trying to figure out if I had said anything or if the judge said -- I was trying to figure out why the

1	defendant didn't come up through the front, and
2	I thought if I listened to the tape maybe I
3	missed something that the judge said or I said
4	or the defense attorney said, and so I listened
5	the tape and I didn't hear anything that
6	addressed that issue.

- Q. Sometime later, did Judge Joseph ask you for a copy of the recording?
 - A. Yes. I believe I bumped into Judge Joseph maybe a week or so after, could have been two weeks, sometime in that time frame, when she was visiting the court, and she asked me for a copy of the tape.
- Q. And did you have someone make a copy for her?

 A. I did. Well, I had had multiple copies made anyway, so I just gave her one that we had.
- Q. And who else did you give a copy to at some point?
 - A. Judge -- Well, I took one to listen to,

 Judge Heffernan asked for one, I think the

 Trial Court asked for several. They wanted it

 several different ways, because it was a little

 choppy, start, stop, start, stop, and a couple

 times the tape captured some but not all. So we

 made sure that the whole day proceedings was

- captured on tape so whoever was listening could hear the whole day, not just a part of the day.
 - Q. That request that came from the Trial Court, can you place that in time at all?
 - A. I would say it was probably a couple of weeks after my seeing Judge Joseph maybe or a week after seeing Judge Joseph or somewhere -- It was sometime after that week that I saw Judge Joseph.
 - Q. And was that Dan Sullivan, general counsel for the Trial Court, who made that request?

 A. My best recollection is, it might have been Joe Jackson from the administrative office, and sometime Dan Sullivan, general counsel, had made a request, but requested not just the day, they wanted the day before, the day after. So they were changing up what they wanted from the clerk's office; so...
 - Q. And to the best of your memory, that request that was changing and asking for the day before, the day after, the whole day, did that come from Joe Jackson or from Dan Sullivan?
 - A. I don't recall. I think that the ultimate request came from Dan Sullivan, from the general counsel's office, but I don't know why he was

- requesting -- That's what he requested. That's my recollection.
- Q. Was Joe Jackson in the administrative office of District Court?
- A. I think so. At the time, yes. I think he dealt with those like tape issues and stuff like that.
- Q. So was he working for working forChief Justice Paul Dawley?
- 10 A. I believe so. The administrative office.

- have for you at this time. Counsel may have some questions for you.

 - Q. And do you have a firm memory as to when that conversation took place? Could have been in the morning, could have been at the lunch break?

 A. I don't have a firm recollection. I thought it was in the morning hour. When I say "morning," I mean around the 9:00, 10:00 area, but I don't -- I couldn't tell you the exact time.
 - Q. Okay. And the first time you noticed ICE in the courthouse was you thought sometime in the morning.
 - A. Yes. I saw him in the hallway.
- Q. And later on that morning you saw him actually in the courtroom.
 - A. I did.
- 21 Q. And he was sitting in the courtroom.

- Q. So if I showed you a blow-up, if I can, of the courtroom. Do you have a recollection -- So we've got two. We've got -- This is a blow-up

- Q. And I'll just put this one here. Do you have a recollection today of where you saw --
- A. I do. He was sitting in the front row on the right-hand side.
- 8 Q. So right up here.

- Q. Okay. And the conversation was about ICE being in the courtroom?
- A. Yes. I let her know that there was a representative from ICE present in the courtroom.
- Q. And you also told her, as I understood it, that Judge Heffernan's policy was no ICE in the courtroom.
 - A. It was not -- I would say her practice.
- 10 Q. Her practice.
- A. Yeah.

- A. Yeah. Because every judge is a little
 different. So it wasn't a policy you had to
 follow, but it was definitely Judge Heffernan's

- A. Sometime over the 1:00 to 2:00 mark.
- Q. And -- So you would have seen him around there or you would have heard that he filed an

- A. I don't recall if he was there earlier in the day, but he definitely was there right at 2:00 when we were starting after lunch. So I assume he was in the courthouse doing something, whether it be he had court business or other filings or -- I don't recall specifically whether he came to the courtroom at all prior to the lunch break.
- 10 Q. And there were court officers there that day;
 11 correct?
 - A. I believe there were two court officers there that day, one who sat with the custody, one in the courtroom, and then at some point the chief came from another court, he kind of supervised three different courts, and he showed up, too.
 - Q. So we can talk about that for a minute. So Wesley MacGregor was there that day?

 A. Yes.
- Q. And he was handling the custody?

 A. Yes.
- Q. And Michael Walsh was there that day as a -A. Yes. I had met him a couple of times. He
 was retired.
 - Q. Retired. He was there as what we call a per

- 1 diem?
- A. Yes.
- Q. And -- But the chief, name is Scott Noe, -A. Yes.
- 5 Q. -- Scott Noe, was not there until later; right?
 6 A. I didn't see him until later. I think I -7 My best recollection is that he came from some
 8 other court at some point during the day. I
 9 don't know when. I was told he was in the
 10 building.
- Q. And the Lunn policy requires that the chief
 court officer, which would have been Noe, would
 do at least two things, one would be to make
 sure that there's notice given to the presiding
 justice of the court that ICE was there; right?
 A. Correct.
- 17 Q. But the presiding justice was out.
- 18 A. Correct.
- Q. And to make sure that the Lunn policy was followed with regard to access to ICE in the lockup; correct?
- A. Yes. I wasn't in the session too often, but that's my understanding.
 - Q. Okay. So if I'm understanding it correctly, your communication to the ICE agent, there was

- 1 only one at that point.
- A. Correct.
- Q. It was two-fold. One is, they're being asked to step outside of the courtroom.
- 5 A. Yes.
- Q. And second -- And that was directly from
 Judge Joseph; right?
- A. Correct.
- Q. But the second was, that, no, he couldn't take
 custody in the lockup. But that was your
 interpretation of what Judge Joseph was saying.
- A. So the second communication with the ICE

 officer would have been after we concluded for

 the day. And the answer to your question is,

 yes, that's what I interpreted Judge Joseph's
- directive to be.
- Q. So -- Okay. Thank you. So -- But sitting here today, you have no memory of having one more conversation with the ICE agent.
- A. I don't recall having any other -- other than
 which door he'd be going out of initially, and
 then secondarily, the -- when he asked for
 permission to go to the lockup. I don't recall
 having other communications with him.
 - Q. So you indicated, when special counsel asked you

- some questions, your previous memory is that ICE
 had taken custody out on the street in the front
 door area.
 - A. I had seen that once before.
- 5 0. You had seen that.
- A. I actually saw it, yeah.
 - Q. Now, court ends; right? Before court ends -Judge Fabricant, special counsel, ran you
 through the transcript of the end of that
 proceeding; right?

- Q. And we heard already that you said something to

 Judge Joseph about ICE being there, right, and

 wanting to take custody in to lockup.

 - Q. And you actually put -- It's on the record that you conveyed that, and she said that's fine, they're not coming in here, in essence; correct?
