Technical Assistance Grants

- 4 TAG applications selected for awards in FY23
- Recipients are 3 municipalities & 1 community action group
- Contract process underway, effective date expected by March
- Proposed projects include:
 - Hiring experts (LSP, risk assessor) to review and interpret technical reports and advise towns/community on site assessment results, response actions, and risk evaluations
 - Increase public understanding of disposal site conditions and enhance public participation in cleanup decisions

March through May

- Agencies required to create red-line document to show comments accepted
- Develop another document explaining why comments were not accepted and why

End of June 2023

- Final EJ Strategy document
- Develop Implementation Plan

- Funds come from a NRD settlement associated with the Blackburn & Union Privileges site in Walpole.



AEPMM Certification for Permanent Solutions

40.1025(7) – The **owner** of the property where an Active Exposure Pathway Mitigation Measure is implemented as part of a **Permanent Solution with Conditions** shall annually certify in response to receipt of a form provided by the Department that:



AEPMM Certification – 40.1025(7) (cont)

- (a) The property owner is aware of his or her obligation to operate and maintain the Active Exposure Pathway Mitigation Measure to resume operation in the event the Measure experiences suspension or failure;
- (b) The property owner is aware that the Department may upon reasonable notice inspect the Active Exposure Pathway Mitigation Measure to ensure that it is operating pursuant to the regimen established at 310 CMR 40.1025;



AEPMM Certification – 40.1025(7) (cont)

- (c) Financial resources are available to the property owner for the immediate repair and/or replacement of components of the Active Exposure Pathway Mitigation Measure in the event the Measure experiences failure; and
- (d) The Active Exposure Pathway Mitigation Measure is operating pursuant to the regimen established at 310 CMR 40.1025.



AEPMM Certification

- Certification letter and form previously discussed with WSC Advisory Committee
- Letters sent to current property owner
- Planning to send 65 certifications (includes PSC and Partial PSC RTNs) first week of March
- If email for property owner is available will send electronically in addition to snail mail
- Letters sent and received will be available on eDEP
