Discussion

- Update on PSI Examinations from prior two months
 - Members compared the pass/fail rate for the J1 and M1 exams. Members agreed that
 the M1 exam pass/fail rate is tending in the wrong direction and members suggested
 the Board conduct an in depth review of the M1 exam questions in the near future.

- Email from Paul Hardiman of Murphy Specialties to the Board of Examiners of Sheet Metal Workers. Originally dated June 2, 2025, regarding a question about fan powered / filtered metal cabinets
 - Members reviewed the additional documentation submitted by Mr. Hardiman and briefly continued the discussion from the last Board meeting. Mr. Hardiman was in attendance and interacted directly with members of the Board. Ultimately the Board believes the fan powered / filtered metal cabinets in question do not meet code standards, so the Board is unable to answer the original question, namely: if a sheet metal license is needed to work with them.
- Email from Paul Hardiman of Murphy Specialties to the Board of Examiners of Sheet Metal
 Workers. Originally dated July 25, 2025, regarding a question about sheet metal chutes.
 - Members reviewed the additional documentation submitted by Mr. Hardiman and briefly continued the discussion from the last Board meeting. Mr. Hardiman was in attendance and interacted directly with members of the Board. The Board directed Mr. Hardiman to send Executive Director Ryan Doherty drawings of the sheet metal chutes in question and will review again during the October Board meeting.
- Letter from Matthew Bedard of Ferguson Enterprises, LLC to the Board of Examiners of Sheet Metal Workers. Originally dated August 20, 2025, submitted with Business application 2025-000273-SM-BSA, regarding Designation of Master Sheet Metal Worker for Massachusetts Operations
 - Executive Director Ryan Doherty advised the Board that this item is not ready for Board review yet as it is currently under review internally with senior counsel. This item will be added to the next meeting agenda after senior counsel review is complete.
