DESCRIPTION OF SERVICES

A moving, hauling, and delivery service which focuses on small-scale moves. Service to provide vehicle, driver/laborer(s) and necessary tools to move a single or few items with a focus on household goods: furniture, appliances, boxed freight, and motorcycles, etc. Towing of boats and other hitched items also available.

TERRITORY TO BE SERVED

Focus on Greater Boston and surrounding suburbs with authority to cover all of Massachusetts.

NOTE:

Quotes determined via phone conversation or email correspondence may be reclassified and adjusted upon visual inspection before initiation and will adhere to these listed rates and conditions.

LABOR RATES

Driver/Laborer: \$70 Minimum for the first hour, \$65 each additional hour with a one hour minimum

Additional Laborer: \$40 Minimum for the first hour, \$30 each additional hour with a one hour minimum

Upcharge – Stairs: When multiple flights of stairs are involved an upcharge of \$15, per man, per flight of stairs past the first average set of stairs(10-12steps) may be applied and may include exterior stairs based on count and layout. Depending upon the number of items, overall weight, or complexity of the move the fee may be reduced to \$10 or waived altogether.

Upcharge – Excessive Weight: An upcharge of up to \$20 per man may be applied to lifting or carrying items of \$150LBS or more depending upon the number of items, number of stairs, or complexity of the move.

Long Carry:

When carrying a distance of greater than 75 feet a fee of \$50 may be applied depending upon the number of items and complexity of the move

Emergency/Last Minute/Late night(24 hours or less)

An additional fee of \$50 above and beyond any other fee or charge may be applied at owner's and driver's discretion.

Additional items outside the originally specified item(s) of the move may be added free of charge upon driver's decision and verbal consent unless otherwise fitting a specific description listed within these rates and conditions.

CURB TO CURB

- Curbside pickup and drop off assumes all items will be brought and waiting to the curbside, loading area, or other easily accessible area by customer
- Driver/Laborer will assist with the loading and securing of items when necessary.

Driver/Laborer: \$50 Minimum for the first hour, \$40 each additional hour with a one hour minimum.

Additional items outside the originally specified item(s) of the move may be added free of charge upon driver's decision and verbal consent unless otherwise fitting a specific description listed within these rates and conditions.

OTHER

A reduction in cost may be applied to moves in which one or two items need to be moved within the home or one or two items need to be move in-route within 10 miles of the Office or Truck at time of arrangement.

Additional items outside the originally specified item(s) of the move may be added free of charge upon driver's decision and verbal consent unless otherwise fitting a specific description listed within these rates and conditions.

MILEAGE CHARGES(Gas and Ware & Tare)

Mileage: .79 cents per mile calculated as round trip from Office location.

A fuel surcharge of an additional .05 cents per dollar per gallon will be added to the base price and rounded off. Surcharge will go into effect when gasoline

prices exceed \$4.25. Fuel prices will be determined by the Energy Information Administration's weekly U.S. Retail Gasoline Prices for Regular Grade for all gasoline vehicles and for Diesel Grade for all diesel vehicles.

TIME CHARGES

The start time will begin at the location of the business upon departure and end at the drop off location if the final destination is within 10 miles of the office or less than ½ hour drive time as estimated by GPS, factoring in traffic. Time will otherwise be calculated as round trip to the office location. All time will be calculated from the office as estimated by GPS, factoring in traffic, regardless of the location of the vehicle unless otherwise agreed upon by the owner or driver in unique situations and fitting other classifications or moves unforeseen at the time of arrangement.

Emergency or Last Minute Charges:

For all immediate help needed or "last minute" inquiries time calculation may begin from the vehicles location at that time and will end as discussed above.

TOLL CHARGES

NOTE: Roaming Area

The area within a 10 mile radius of Boston City Hall presently located at 1 City Hall Square, Boston, MA 02201-1001, or the location of the business as the origin of departure, is considered the vehicle's roaming area.

Toll charges will be applied starting from the first pick up location for all jobs within the roaming area. All tolls will be applied when traveling outside the roaming area.


