**Item 1: Transportation Rates**

Labor: \$45 per person, per hour

Charge per hour is uniform for supervisor, driver, and crew members.

Truck: \$25 per hour for 16-foot straight truck

\$35 per hour for 24-foot straight truck

Mileage & Fuel: Calculated at \$2.00 per mile

**Item 2: Surcharges**

A 10 percent surcharge based upon subtotal on final bill applies for:

- Weekends and Holidays

A 15-25 percent surcharge based upon subtotal on final bill applies for:

- Subpeak (15%); Rates in effect from July 30 to August 24
- High-peak (25%); Rates in effect from August 25 to September 3

**Item 3: Liability**

Smith Moving will provide a limited liability of \$.60 per pound per article at no additional cost to the shipper. Shipper may elect to waive limited liability and choose a valuation option.

**Item 5: Payment**

All charges must be paid in full by time of delivery. Payments can be made in the form of cash, cashier's check, or certified check. Credit cards can be accepted for an additional 2 percent fee added to subtotal of final bill.

**Item 6: Notes**

- A. All hourly charges begin the time the crew leaves the dispatching location and ends upon the actual or an estimated time of return.
- B. Smith Moving has a three (3) hour minimum charge for all moves. Once the minimum is satisfied, charges are calculated and rounded up to the next quarter hour.
- C. The Mileage and Fuel rate is determined by MapQuest. The start is determined by the dispatching location and is ended at the same dispatching location.
- D. Smith Moving does not move pianos.
- E. Smith Moving does not assume responsibility for loss or damage due to breakage of china, glassware or similar fragile items, unless packed and unpacked by the mover or unless visible exterior damage is done to the container.
- F. Smith Moving does not assume responsibility for loss or damage to items previously broken, repaired, or glued.
