George Dilboy Post #529 Inc. V.F.W. of U.S. (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 13, 2011, regarding an alleged violation of M.G.L. c. 138, §15A and M.G.L. c.138, §1. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Caroline Guarino's Report.

## **FACTS**

- 1. On September 13, 2011, Investigator Guarino conducted an electronic search of the Secretary of the Commonwealth website relative to the licensee George Dilboy Post #529, Inc. V.F.W. of U.S.
- 2. The records of the Secretary indicated the licensee organized on May 8, 2006.
- 3. The records of the Secretary indicated the licensee had filed an annual return with a list of corporate officers for 2011.
- 4. Administrative review indicates the licensee has had the license since 1973.
- 5. Administrative review indicates the licensee has failed to file a change of Officers / Directors in this corporation for several years (since 1973) with the local licensing board and with this Commission.
- 6. Administrative review indicates the licensee has failed to file annually (since 1983) a list of names and residences of corporate officers, together with the amount of salary or compensation received by each employee engaged in the handling or selling of alcoholic beverages.
