# **DECISION**

WOODY'S INC. D/B/A WOODY'S LIQUORS 483 BROADWAY STREET SOMERVILLE, MA 02145 LICENSE#: 00085-PK-1130

VIOLATION DATE: 6/06/2023

HEARD: 11/07/2023

Woody's Inc. d/b/a Woody's Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 7, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Kenny and Watson's Minimum Purchase Age Compliance Check Field Report.

#### FINDINGS OF FACT

- 1. On Tuesday, June 6, 2023, at approximately 6:12 p.m., Investigators Kenny and Watson ("Investigators") conducted a compliance check at Woody's Inc. d/b/a Woody's Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a can of White Claw Mango Hard Seltzer, for four dollars (\$4.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 for more than twenty-five years.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
